Mapping Customer Operations (MCO) is responsible for the supply management of approximately 190,000 National Stock Numbers in four federal supply classes—7641 (Aeronautical), 7642 (Hydrographic), 7643 (Topographic), and 7644 (Digital CD/DVD). MCO also manages special programs including Fleet Allowance, Flight Information Publications, and War Reserve

While this is "nice to know" information, MCO understands that most of our customers just want to order and receive mapping products with the least amount of hassle. We have no control over some of the hurdles you face, such as AMPS, but know that MCO is always available to help you through the process. Attention Maritime Customers!!!

Looking for Great Circle and Operating Area Charts in the DLA Map Catalogs? Great Circle Charts have been moved to the Miscellaneous Hydrographic layer in the stand-alone catalog and Interactive DLA Map Catalog in FEDMALL. Operating Area Charts based on Electronic Navigation Charts (ENC) information are now located in the Certified Printed Electronic Navigation Charts (CPENC) layer and are identified in the DLA Map Catalogs with "Operating Area Chart" in the title. Automatic Distribution (AD) Reduction

NGA continues to work collaboratively with DLA to enhance the automatic distribution process and reduce printing and distribution costs. In a continuous effort to support fiscal budget constraints, customers are limited to receive a maximum of 5 copies each time a new edition becomes available. These copies serve as the official notification to request additional items to support operational requirements. Changes are processed on the customers' behalf. If additional copies are required, customers can place orders using their local logistical system, Fed-Mall, DLA Map Catalog, or contacting MCO.

This change does not impact Fleet Allowance, FLIPs and Specialty products (for example EVCs, Military Installation Maps).

This change became effective 15 MAR 2024.

New Map / Chart Accounts

To obtain mapping products from MCO, customers must first register in the Account Management & Provisioning System (AMPS) at https://amps.dla.mil/ and request a role within the Mapping Enterprise Business System (MEBS). Go to https://amps.dla.mil/ to register and click on the link to request a role. You will receive email confirmation once approved. To access your account, log in to AMPS and select your MEBS role.

A couple of registration hints—you will be asked to identify your supervisor, and security officer. These individuals will receive AMPS-generated emails throughout the registration process and must be answered for the account to be approved. You will also need to know your last Information Assurance training date. One last item you will need is your DODAAC, which will be your map/chart account number. Please keep all AMPS/MEBS related emails, especially the one containing your SAAR number. Changing account custodians on an existing account is done in much the same way. as opening a new account. New custodians must also register in AMPS using the map account DODAAC. As always, if you have any questions give us a call (800-826-0342).

The enterprise continues to experience increased costs associated with the print and distribution of DoD and FAA Flight Information Publications (FLIP). Customers are strongly encouraged to review their FLIP quantities to right-size their subscriptions. DLA's MCO Account management section can assist in updating accounts and FLIP subscriptions.

Non-Standard Map Requests

MCO has established a mailbox for our customers who need to request printing of non-standard maps (customized products that do not have a national stock number). If you have a requirement for this type of product, the procedure for placing an order is outlined below. As with all products ordered through DLA MCO, there is no charge to the customer for printing or shipping when the order is placed in accordance with the outlined process, however applicable fees may apply for some unique features You must have a digital print file that can be replicated to transmit with your request.

Steps for Ordering Non-Standard Maps:

- * Send an email request to: <u>DLAAVNNonStd@dla.mil</u>. Required information includes name and phone number for the point of contact and account DoDAAC.
- * You will receive a response with a "Non-Standard Map Request" form that must be completed and sent with the print file.
- * Transmit the digital print file and the completed request via DOD SAFE (https://safe.apps.mil/). Specify in the notes that this is a "Non-standard request, provide POC name" and send to the following addresses:
