Approved Defense Logistics Management Standards Change 1483, 867I Materiel Issue of Expended Ordnance

1. ORIGINATING SERVICE/AGENCY AND POC INFORMATION:

2. REASON FOR CHANGE:

- a. <u>Bottom Line Up Front</u>: Update the Defense Logistics Management Standards (DLMS) 867I (Issue) transaction set to include a new type of Product Transfer Type for Ordnance Expenditure and provide a reason for the expenditure. See Enclosure 1. This change has audit remediation implications but only impacts the Navy Ordnance Information System (OIS) and Defense Automatic Addressing System (DAAS).
- **b.** <u>Background</u>: Currently in Navy OIS, expenditures of ordnance are generically issued as an 867I with a Product Transfer Type Code of "BQ (Other)" that is followed by a custom Navy OIS transaction (i.e., an 'ATR') to track the type and reason of the expenditure. This custom transaction is used to satisfy ordnance expenditure requirements within Navy policies identified within NAVSUP P-724 CONVENTIONAL ORDNANCE STOCKPILE MANAGEMENT POLICIES AND PROCEDURES (Reference b.(1)) for specific ordnance quantities expended under categorized reasons. Removal of the 'ATR' transaction within Navy OIS and consolidation of reporting requirements into the 867I transaction will enable the Navy to streamline financial and inventory reporting based on expenditure scenarios.

3. CHANGE IN DETAIL:

- **a. Technical Details:** Two additions are requested for the 867I:
- (1) Add a new code titled "Ordnance Expenditure" for the Product Transfer Type Code (2/PTD01/10) element under the Product Transfer and Resale Detail (PTD) segment.
- (2) Add a new code for the Industry Code segment (LQ) in the DLMS 867I to indicate the "Ordnance Expenditure Reason." This would be a three-character alphanumeric code that would map to values in Navy OIS.
 - b. Revised Transaction Flow: N/A
- **4. IMPLEMENTATION TARGET:** Quarter 4 of Fiscal Year 2026.

5. TECHNICAL IMPACT:

a. Additions or Changes to Data Elements:

- (1) Add a new code titled "Ordnance Expenditure" for the Product Transfer Type Code (2/PTD01/10) element under the Product Transfer and Resale Detail (PTD) segment.
- (2) Add a new code for the Industry Code segment (LQ) in the DLMS 867I to indicate the "Ordnance Expenditure Reason." This would be a three-character alphanumeric code that would map to values in Navy OIS.
 - b. Automated Information Systems (AIS): Navy Ordnance Information System (OIS).
- **c.** <u>Defense Automatic Addressing System (DAAS)</u>: Update mapping to reflect the changes in Enclosure 2, as necessary.

C14.1.2.1. Issue Transaction. Issue Transaction is DLMS 867I Issue, identified by ASC X12 beginning segment (1/BPT04/20) Report Type Code 01 – Product Transfer. This transaction provides MILSTRAP legacy Document Identifier Code (DIC) D7_ functionality. The Issue Transaction function is further broken down by the 2/PTD01/10 Product Transfer Type Code which provides the functionality of the third position or the MILSTRAP legacy DIC. Table C14.T1 shows the specific product transfer type code corresponding to the MILSTRAP legacy DICs.

C14.1.2.1.1. For Navy ordnance-related expenditures, Product Transfer Type Code "OE – (Ordnance Expenditure)" will be used in 2/PTD01/10 in a DLMS-only transactional environment. When Product Transfer Type Code OE is present, the transaction must also contain the Expenditure Reason Code 121. Use of these two corresponding data points will enable the Navy to streamline financial and inventory reporting based on expenditure scenarios.
