2. REASON FOR CHANGE:

a. **Bottom Line Up Front:** This administrative change resolves issues with the Defense Logistics Management Standards (DLMS) 870S (Supply Status) Implementation Convention (IC) Reference Segment position 87 when using American National Standards Institute (ANSI) X12 based Extensible Markup Language (XML) tagging.

b. **Background:** On June 26, 2025, representatives from the Defense Automatic Addressing System alerted DEDSO about issues being reported by system programmers of the Enterprise Logistics Management System (ELMS), formerly Defense Property Accounting System. The error being reported about the DLMS 870S XML schema only allowed code 60 (Account Suffix Code) to be used in 2/REF04-03/87, even though 2/REF04-01 specifically mentions in the DLMS notes that codes 10 (Account Managers Code) and AT (Appropriation Number) are acceptable values for 2REF04-03/87.

a. **Technical Details:** Missing codes in the 2/REF04-03/87 segment have been added to the DLMS 870S (Supply Status) IC as described in the Enclosure, and a new X12 based XML schema has been generated and posted on the DEDSO IC website.
