#### MEMORANDUM FOR: DISTRIBUTION

SUBJECT: Approved DLMS Change (ADC) 63, Revision to DLMS Supplement 527D to Satisfy an intra-Navy Requirement for Standard Unit Price on the Advance Receipt Information Transaction (Staffed by PDC 73) (Supply/MILSTRAP)

This change to the DoD 4000.25-M, Defense Logistics Management System (DLMS), modifying the DS 527D, Due-In/Advance Receipt/Due Verification, is required to support continued logistics operations in a DLMS/DLSS environment. The updated DS will be posted to the DLMSO web site (http://www.dla.mil/j-6/dlmso/ICs/Default.htm) within 30 days from the above date for implementation planning. DLMSO will concurrently pursue coordination/approval with the DoD Logistics Functional Working Group, the DoD Electronic Data Interchange Standards Management Committee (EDISMC), and the Federal EDI Standards Management Coordinating Committee (FESMCC) for Federal implementation convention (IC) revisions.

# APPROVED DLMS CHANGE (ADC) 63 REVISION TO DLMS SUPPLEMENT 527D TO SATISFY AN INTRA-NAVY REQUIREMENT FOR STANDARD UNIT PRICE ON THE ADVANCE RECEIPT INFORMATION TRANSACTION.

#### 1. ORIGINATOR:

a. Service/Agency: Navy

#### 2. FUNCTIONAL AREA: Primary. Supply

#### 3. REQUESTED CHANGE:

**a. Title:** Revision to DLMS Supplement 527D to Satisfy an Intra-Navy Requirement for inclusion of 'Standard Unit Price' on the Advance Receipt Information Transaction.

#### b. Description of Change:

(1) To support Navy legacy system requirements, NAVSUP requires that the 'standard unit price' be added to the 527D for use with the DLMS Advance Receipt Information (ARI) transaction. The 527D ARI transaction is the DLMS equivalent of the MILSTRAP Prepositioned Materiel Receipt (PMR) transaction. Navy currently cites the 'standard unit price' in MILSTRAP PMR transactions, using an intra-Component data field.

(2) This data requirement is being incorporated to accommodate a Navy specific requirement, and does not require DoD-level business rules. Intra-Component procedures/business rules must be in place identifying the purpose/use of the 'standard unit price' in an ARI transaction. Use of the data is optional and marked as a Navy requirement to accommodate their documented intra-Component requirement. If other Components choose to use this optional data in DLMS, the data cannot be mapped back to DLSS during operation in a mixed DLMS/DLSS environment, unless the placement in the DLSS transaction is identified to DLMSO. Further, the data will not be acted upon by trading partners outside your Component as no DoD-level requirement or procedures have been established. In response to this proposal request addresses, other than Navy, that have a requirement for including the 'standard unit price' in ARI transactions on an intra-Component basis, document that requirement to DLMSO.

## c. Procedures:

(1) DoD level procedures are not required for this intra-Component requirement.

(2) NAVSUP procedures are defined in the Naval Supply Procedures, NAVSUP Publication 485 (Revision 3). To the maximum extent, Navy transactions follow existing DLSS/DLMS transaction formats; however, Navy use of DLSS intra-service fields requires the use of data not included in the DoD standard DLSS transaction.

# d. Alternatives: None

# 4. REASON FOR CHANGE:

**a.** DLMSO memorandum, November 7, 2001, subject: Inclusion of Defense Logistics Standard Systems (DLSS) Data/Business Processes in the Defense Logistics Management System (DLMS), highlights the need for Components to document their intra-Component data requirements to DLMSO for inclusion in the DLMS. Without such documentation, DLMSO has no visibility of the requirement. One of the categories identified in the memorandum is data which is transmitted in DLSS intra-Component use fields, but which is undocumented in the DLMS. Navy originated this change proposal in response to the November 7, 2001 memorandum.

**b.** Navy currently includes 'standard unit price' in MILSTRAP PMR transactions (Document Identifier Codes DU\_ and DW\_). Navy cites the data in a multi-use field which allows entry of Component prescribed data for intra-Component use. Navy indicates that their wholesale system uses the PMR transaction to provide the 'standard unit price' to Navy's retail system, where it is recorded in the stock point's Master Item Stock Record. The DLMS Supplement (DS) to the 527D Federal Implementation Convention accommodates the majority of Navy's data requirements, however Navy's unique requirement for data exchange of the 'standard unit price' is not currently carried in the DS 527D. Changes to the DLMS procedures are not required.

# 5. ADVANTAGES and DISADVANTAGES:

## a. Advantages:

(1) Incorporates a documented intra-Navy data requirement into DLMS.

(2) Establishes data element for standard unit price in the 527D. Data element can be opened up for use by additional DoD Components if requirement is identified to DLMSO.

## **b. Disadvantages:** None known.

# 6. IMPACT:

**a. Transaction Set(s):** The 004010 version of the 527D Material Due-In and Receipt IC is affected by this change.

**b. Segment(s):** AMT segment. Open optional segment 2/AMT/100 for use. Add the following segment level note: **DLMS Note**: *"This segment is for optional use as needed to support intra-Component requirements."* 

c. Data Elements(s): 2/AMT01/100. Add Code NT – Unit Value. Add DLMS notes 1 and 2 as follows:

- **1.** " Use as needed to cite the standard unit price in Advance Receipt Information (ARI) transactions for intra-Component use. Component level procedures are required."
- "DLMS enhancement to allow for entry of an intra-Navy data requirement cited in DLSS DI Code DU/DW, record positions 60-66. Navy has identified a requirement for standard unit price for intra-Navy use. NAVSUP procedures are defined in the Naval Supply Procedures, NAVSUP Publication 485. See introductory DLMS note 4.a. for inter-Component use of this data"

**Justification:** In its use of an intra-Component use field in the PMR, DI Codes DU\_ and DW\_ (rp 60-66), the Navy record layout contains a data field for the standard unit price of an item listed in a Prepositioned Material Receipt.

**d. Publication(s):** DoD 4000.25-M, DLMS Supplement to the 527D Federal Implementation Convention.
