

MEMORANDUM FOR: SUPPLY PRC MEMBERS

SUBJECT: Approved DLMS Change 78, Addendum for Revision to DLMS Supplement (DS) 5 17M, Material Obligation Validation (MOV) (Supply)

This addendum provides a revision to the DoD 4000.25-M, Defense Logistics Management System (DLMS), modifying the DS 5 17M, required to support continued logistics operations in the DLSS/DLMS environment. The updated DLMS Supplement will be posted to the DLMSO web site (<http://www.dla.mil/j-6/dlms/ICs/Default.htm>) within 30 days from the above date for implementation planning. DLMSO will concurrently pursue coordination/approval with the DoD Logistics Functional Working Group, the DoD Electronic Data Interchange Standards Management Committee (EDISMC), and the Federal EDI Standards Management Coordinating Committee (FESMCC) for Federal implementation conventions (IC) revisions.
