

MEMORANDUM FOR: SUPPLY PRC MEMBERS

SUBJECT: Approved DLMS Change 93, Inclusion of Status Code BP in Material
Obligation Validation (MOV) Procedures (Supply/MILSTRIP)

This attached change to DOD 4000.25-1-M, Military Standard Requisitioning and Issue Procedures (MILSTRIP), and DOD 4000.25-M, Defense Logistics Management System (DLMS), is approved for staggered implementation. Components **may** defer associated automated processing pending logistics systems modernization. Components should identify implementation dates to DLMSO. DLA has reported that this process is implemented under legacy **systems** and will perpetuate under modernization.

Inclusion of Status Code BP in MOV Procedures

1. ORIGINATOR:

a. **Service/Agency:** DLA

2. FUNCTIONAL AREA: Supply

3. REQUESTED CHANGE:

a. **Title:** Inclusion of Status Code BP in MOV Procedures

b. **Description of Change:** This change corrects documented procedures for MOV to include Status Code BP.

c. **Procedures:** Revise MILSTRIP as follows:

C7.1.1.2. A materiel obligation is herein defined as that unfilled portion of a requisition (for a stocked or nonstocked item) that is not immediately available for issue but is recorded as a commitment for future issue, either by direct delivery from vendor or backordered from stock. This includes both NSN and non-NSN items. Accordingly, MOV will pertain to those requisitioned items assigned Status Codes BB, BC, BD, **BP**, BV, and BZ, as applicable.

| Status Code BP may be deferred for inclusion under logistics system modernization.

4. REASON FOR CHANGE:

a. Status Code BP was developed for use with extended (or deferred) required delivery date (RDD) procedures (Codes X and S) subsequent to the documentation for MOV procedures. Prior to the change that developed Status Code BP, deferred requisitions were placed in BB status and validated as part of MOV. In an apparent oversight, the list of status code values applicable to MOV was not updated to include Status Code BP. However, DLA, under legacy system processing, did incorporate BP status under MOV with no problems identified by the Components. It is the intention of DLA to perpetuate inclusion of BP status under MOV during modernization. This change is provided to correct the administrative error and allow for phased implementation if Components do not currently include deferred requisitions in their MOV processing.

b. For ease of review the following information is provided:

MILSTRIP Status Code BB: Item is back ordered against a due-in to stock. The ESD for release of materiel to the customer is contained in rp 70-73.

MILSTRIP Status Code BP: Requisition has been deferred per customer instructions. The ESD is in rp 70-73.

Extended RDD Code X: Customer enters number of months in rp 63-64 preceded by an X in rp 62. The use of extended RDD Code X does not preclude earlier delivery if material is available; however, supply sources deferring support provide BP status.

Extended RDD Code S: Customer enters number of months in rp 63-64 preceded by an S in rp 62. The use of extended RDD Code S indicates the customer's desire that material not be released prior to 50 days before expiration of the extended RDD. The supply source will not ship earlier even if material is available.

5. ADVANTAGES AND DISADVANTAGES:

a. **Advantages:** Advances the objective of consistent processing across Components and clarifies specific business rules.

b. **Disadvantages:** None known.
