SUBJECT: Approved DLMS Change (ADC) 123, New DLMS Management Code W in Support of Medical Assembly Requirements for use with DLMS Supplement (DS) 527D (Supply/Staffed by PDC 121)

This memorandum forwards an approved change to DOD 4000.25-M, Defense Logistics Management System (DLMS). This change incorporates a requirement of the U.S. Army Medical Materiel Agency (USAMMA) enterprise resource planning (ERP) effort into DLMS. The change is approved for immediate use by USAMMA and DLA's Distribution Standard System (DSS) to improve procedures involving transfer of DOD deployable Medical Systems (DEPMEDS) materiel from Army maintenance to the adjacent DEPMEDS assembly.

ATTACHMENT TO APPROVED DLMS CHANGE (ADC) 123 New DLMS Management Code W in Support of Medical Assembly Requirements for use with DLMS Supplement (DS) 527D

1. ORIGINATOR:

- a. Service/Agency: Defense Logistics Agency (DLA).
- **b.** Originator: Mary Day, DLA MILSTRAP Focal Point.

2. FUNCTIONAL AREA: Supply, DOD Medical Unit Assembly Program.

3. REQUESTED CHANGE

a. Title: Addition of New Management Code "W" to DLMS for use in DS 527D.

b. Description of Change: The DLA and U.S. Army Medical Materiel Agency (USAMMA) plan to add new management code "W" for use with non-MILS transaction Document Identifier (DI) code C2H, Advance Data for Assembly Other Than Procurement, to facilitate procedural changes (i.e., physical flow of DOD Deployable Medical Systems (DEPMEDS) materiel) and improved automated processing (i.e., elimination of "wash" transactions in central receiving). By using the new management code value in the DS 527D Advance Receipt Information (i.e., 2/LQ01/130, qualifier 84 (management code) with 2/LQ02/130 code value = W) USAMMA could direct that the DEPMEDS materiel move directly from the co-located Air Force maintenance depot to the adjacent DLA DEPMEDS facility. This would eliminate additional materiel handling, reduce the distance the materiel is moved, and would eliminate a "wash" (i.e., receipt and shipment) in core DSS. The audit trail would still be intact since DSS DEPMEDS would receipt the item and acknowledge receipt to USAMMA.

c. Procedures:

(1) Add a new DLMS Management Code W for use with DS 527D Due-In and Advance Receipt Information (ARI) transactions as follows:

W	527D Due-In and ARI transactions	For unit assembly programs, materiel intended for immediate transfer to adjacent assembly area, in accordance with agreed upon procedures, to preclude materiel movement from maintenance to central receiving.

(2) No change is required to DOD 4000.25-2-M, MILSTRAP as Management Code W is approved for use with DOD 4000.25-M, DLMS, and can be found on the DLMSO website at: http://www.dla.mil/j-6/dlmso/logdrms/logview/LQVQCrpt.asp?FindCode=84&tockword=&Code37=00&camefrom=&inat=. The new Management Code W can be used by DLA/USAMMA for the non-MILS DI Code C2H transactions.

(3) Revise DOD 4000.25-M, DLMS, Volume 2, Chapter 12 by adding a new paragraph to explain the use of new management code W (e.g., <u>Movement of Medical Assembly Materiel</u>. When owners direct relocation of medical materiel from a maintenance activity to the assembly point collocated with the maintenance activity they shall establish a due in, IAW (cite applicable section) citing Management Code W for the intransit material. Also, provide a DS 527D to the ultimate maintenance activity (i.e., DEPMEDS assembly point), citing Management Code W, etc.").

(4) Revise DAASC map of DS 527D for 527D to C2H translation to indicate that when LQ01=84 (management code), it should be translated to DI code C2H RP 70=W.

(5) Per DLA, the internal DLA publications will be revised to provide for entry of the Management Code in record position 70 of DI Code C2H, Advance Data for Assembly (Other Than Procurement).

4. REASON FOR CHANGE: Approved DLMS Change (ADC) 51, Revisions to DLMS Supplements 527D and 527R in Support of Medical Requirements for Assembly Component and Prime Vendor Advance Receipt Information & Receipt Transactions, changed DLMS Supplement (DS) 527D to accommodate functionality and data content of the DLA-unique DI Code C2H as used in an inter-Component environment by the U.S. Army Medical Materiel Agency (USAMMA) and DLA. Accordingly, USAMMA's Enterprise Resource Planning (ERP) system now uses the DS 527D to communicate advance receipt information to DLA's Distribution Standard System (DSS) using the DOD corporate translation services by the Defense Automatic Addressing Service Center (DAASC), who translate the DS 527D to DI code C2H for DSS use. The USAMMA and the Defense Distribution Center agree that movement of materiel from maintenance to central receiving (with the associated receipt and subsequent shipment transactions) could be eliminated if there were a way to systemically communicate that the materiel should be directly delivered to the adjacent DEPMEDS assembly area. The DS 527D already accommodates management codes; therefore, only minor changes would be required in USAMMA's ERP and DAASC's translation map for DS 527D.

5. ADVANTAGES AND DISADVANTAGES:

a. Advantages: Improves the medical assembly process by reducing the number and distance of physical movements as well as streamlining the audit trail for materiel moving from maintenance to final assembly point.

b. Disadvantages: None known.

6. IMPACT:

- **a.** Update DAASC translation map for DI code C2H to ensure the DI code C2H management code is accurately translated from the USAMMA-generated DS 527D.
- **b.** Change USAMMA DS 527D to incorporate use of management code value "W" in advance receipt information transaction sets for materiel to be sent from AF maintenance to DSS DEPMEDS.
- **c.** Change DSS DEPMEDS application to accept DI code C2H with RP 70 reflecting Management Code W (instead of blank).
