4. REQUESTED CHANGE:

a. Title: Update of DLMS Supplement 888A Small Arms Data Change (Supply)

b. Description of Change: This change updates DLMS supplement 888A, Small Arms Data Change, to stipulate that the DODSASP procedure for changing a serial number does not extend to the item unique identification (IUID) unique item identifier (UII), and to make various administrative updates to DS 888A necessary to correct or clarify information.

c. Procedures: Revise DS 888A as shown in the table at paragraph 7.

5. REASON FOR CHANGE:

a. DOD Small Arms reporting policy calls for tracking small arms by serial number. Current DLMS and MILSTRAP DODSASP procedures allow for modification of the small arms serial numbers as follows (excerpts from DLMS, Volume 2, chapter 18, subparagraphs C18.5.1.5 and C18.7.2.1):

"C18.5.1.5. Identify duplicate serial numbers received from the DoD Component Registries, as a minimum, on a quarterly basis. The appropriate DoD Component shall be contacted to verify duplicates and the DoD Registry will issue selected suffixes to modify affected serial number(s) for all but one of the duplicate numbers. Weapons with duplicate serial numbers located in the wholesale system shall be modified first, to the extent possible, in order to

maintain an audit trail for all modification actions:"

"C18.7.2.1. <u>Duplicate Number Validation</u>. If duplicate serial numbers appear during the next check, and are owned by a single DoD Component, the DoD Component Registry shall be notified to validate the serial numbers. If duplicate serial numbers remain after this validation, the DoD Component Registry shall request altering instructions from the DoD Registry to modify affected serial number(s). The DoD Registry shall issue modified serial numbers (using selected alpha suffixes) and maintain a complete historical cross-reference record."

b. DLMSO has revised 22 DLMS transactions which have unique item tracking (UIT) or small arms reporting capability, by serial number, to incorporate the IUID UII data element in addition to the serial number, in support of evolving IUID policy. DS 888A was a candidate for revision to add the UII, however the purpose of the serial number function performed by DS 888A is to change the serial number as allowed by DODSASP procedures. This change capability would not apply to the UII under DOD IUID policy which states that the concatenated UII will not change over the life of the item. Accordingly this change documents that the UII was not added to DS 888A by intent. This change was discussed at the April 25, 2007 Joint Small Arms Coordinating Group Meeting. The JSACG concurred with the change.

6. ADVANTAGES AND DISADVANTAGES:

a. Advantages: Updates DS 888A to clarify that the small arms serial number change capability is not intended for use to change the UII for a small arms since IUID policy is that the UII will not change over the life of the item. PDC 262 also incorporates various administrative updates necessary for clarification or correction.

b. Disadvantages: No disadvantage for existing requirement for small arms reporting by serial number, however there appears to be a disconnect between existing DODSASP procedures which allow modification of a serial number, and IUID policy which states that "The concatenated UII will not change over the life of the item. Therefore, the component data elements of the concatenated UII will not change over the life of the item." The serial number is a component data element of the UII. Logistics IUID policy is evolving and areas such as this may be addressed in the future.

7. This change was staffed by PDC 262, Update of DS 888A Small Arms Data Change. DOD Component responses to PDC 262 are as follows:
