# 2. FUNCTIONAL AREA: Primary: Supply/ Logistics

# **3. REFERENCES:**

**a.** Functional Requirements for DLA's implementation of Base Realignment and Closure (BRAC) Retail Supply, Storage And Distribution (SS&D)/Inventory Management and Stock Positioning (IMSP) Spiral 2.

**b.** AT&L Memorandum transmitted April 21, 2010, subject: Proposed Changes in support of Navy BRAC Inventory Management and Stock Positioning (IMSP) Spiral II. This memo documents Deputy Assistant Secretary of Defense for Supply Chain Integration (DASD(SCI)) direction provided to DLA and Navy authorizing immediate implementation of this DLMS change.

# 4. **REQUESTED CHANGE:** Revisions subsequent to staffing are highlighted.

**a. Description of Change:** This change request is for the assignment of a new Management Code for use on applicable DLMS transactions associated with requisitioning of Navy-funded non-production support materiel ordered under DLA-Navy BRAC IMSP. The Management Code will be used to trigger special processing rules in DLA's Enterprise Business System (EBS).

**b. Background:** As a result of the 2005 BRAC decision, retail supply, storage and distribution (SS&D) functions and associated infrastructure supporting Service industrial/maintenance sites will transfer to DLA. In Spiral 2 there will be two Naval Shipyards and three Fleet Readiness Centers (FRCs) transferring to DLA. Items to be purchased in support of operations at the Navy sites, but not used for direct support of ship/aircraft maintenance, will be purchased by DLA. This type of materiel is referred to as non-production or non-industrial materiel. In order to recognize these requirements and ensure these request are not backordered and no corresponding DLA orders are created using Defense Working Capital Funds (DWCF) a new unique management code will be used.

#### c. Detailed Procedures:

(1) The Navy industrial activity (IA) will submit funded requisitions for nonproduction materiel to DLA citing the new non-production materiel Management Code N. DLA will process the Navy-funded requisitions for non-production materiel requisitions by applying unique logic developed to allow the request to process to appropriate source for fulfillment, including sourcing against unprotected on-hand assets at any DLA storage activity. Unique logic will be limited to FRC and Shipyard requests. All other requisitions will bypass this logic within EBS.

(2) For continued visibility, the new management code will be perpetuated to the

requisition modification, and follow-up by the Navy submitter (that is, transactions that may be processed as new requisitions if unmatched to a SoS record). It will also be perpetuated by DLA (EBS) to the supply status. **Staffing Note:** The original procedures requested perpetuating the non-production materiel management code beyond the requisitioning process, to include materiel release orders and shipment status. However, the use of a management code on the materiel release order is normally intended to trigger a specific business process within the storage activity. Since no specific action is required, the perpetuation of the management to the release order and shipment status has been removed.

(3) Requirements for non-production materiel may not be submitted via Navy requisition alerts whereby materiel is purchased and pre-positioned by DLA prior to submission of a Navy-funded requisition. If a requisition alert is received by EBS and identified as a non-production materiel requirement, the requisition alert will be rejected with applicable supply status<sup>1</sup>.

(4) DLA EBS will place Navy-funded requisitions with Management Code N in backordered status (BB) while attempting to source the requirement. Only unprotected assets may be used to satisfy non-production materiel requisitions.

(a) NSY. If unprotected assets are not available locally to support NSY requirements, DLA will submit a DLA requisition to the Navy Enterprise Resource Program (ERP) (Routing Identifier = NRP) for availability of Real-time Reutilization Asset Management (RRAM)<sup>2</sup> system free issue assets.

(b) FRC. FRC requirements will be sourced from local unprotected stock or, if not available, network stock.

(c) If materiel is not available through above sourcing methods, the requirement will remain in backordered status and will be sent to the designated DLA forward buyer for support.

(5) Update DLMS Supplements as shown in Enclosure 1.

(6) The non-production materiel flow diagram is shown at Enclosure 2.

(7) Update the DLMS Dictionary and MILSTRAP, Appendix 2.6, Management Codes, at Enclosure 2 for the following new management code.

CODE	EXPLANATION
N	Non-production Materiel. Identifies Navy-funded requirements not associated with direct support for ship/aircraft maintenance. Applicable to Navy requisitions submitted to DLA under industrial activity support agreement and may be perpetuated to supply status.

#### d. Alternatives: None identified.

**5. REASON FOR CHANGE:** DLA requires ability to recognize a request for Navy-funded nonindustrial materiel or miscellaneous items that the industrial activities need that are not direct support for ship/aircraft maintenance.

# 6. ADVANTAGES AND DISADVANTAGES:

**a.** Advantages: EBS will recognize the requisition for Navy-funded non-industrial materiel or miscellaneous items that the industrial activities need that are not direct support for ship/aircraft maintenance. The management code allows visibility of non-production materiel through release and shipment.

b. Disadvantages: None identified.

# 7. IMPACT:

#### a. Policy and Procedures:

(1) On March 11, 2010, the Deputy Assistant Secretary of Defense for Supply Chain Integration authorized DLA and Navy to proceed with development of procedures associated with the industrial activity support agreements under BRAC.

(3) Update to DoD 4140.1-R, DoD Supply Chain Materiel Management Regulation, to address non-production materiel requisitioning under SS&D is recommended.

**b. DLMS Supplements and Procedures.** Update DLMS Supplements: 511R, 511M, 869F, 870S.

**c. DLMS Data:** There is no new data content other than the additional value for management code as identified above.
