4. REQUESTED CHANGE:

a. Description of Change: The DLMS Supplement (DS) 846A Asset Reclassification transaction will be used in support of Marine Corps and DLA_re-identification of assets to support less than unit of issue functionality at the Marine Corps Maintenance Centers (MCMC).

b. Marine Corps Maintenance Centers will use the following new data elements (data elements defined for use by Navy BRAC initiative under ADC 381 (reference 3c)) as part of DLMS 846A Asset Reclassification: Local Stock Number (LSN), Unit of Use, Unit of Use Indicator, and unit of use conversion factor.

c. DS 846A is a DLMS enhancement in its entirety, with no MILSTRIP/MILSTRAP equivalent transaction. ADC 376 (reference 3d) and the Addendum to ADC 376 (reference 3e) revises DS 846A in support of Navy BRAC. This change modifies DS 846A in support of MC BRAC. This change does not impact Navy BRAC Retail Supply, Storage and Distribution (SS&D) Inventory Management and Stock Positioning (IMSP) use of DLMS Asset Reclassification transaction and procedures documented by ADC 376 and Addendum to ADC 376.

d. Background:

(1) **BRAC Concept.** As a result of the 2005 BRAC decision, storage and distribution functions for Operating Material and Supplies associated infrastructure supporting the Marine Corps Maintenance Center sites will transfer to DLA. The Marine Corps sites are Maintenance Center Albany (MCA) and Maintenance Center Barstow (MCB). The intent of the directive is to significantly improve combat effectiveness while reducing costs by developing a world-class, cost-effective supply chain focused on readiness; taking every opportunity to eliminate waste, reduce touches, reduce cost, and improve readiness. In accordance with the signed CONOPS, DLA has agreed to provide S&D support to the Marine Corps sites.

(2) Policy: DLA advises that on March 11, 2010, the Assistant Deputy Under Secretary of Defense, Logistics and Materiel Readiness, Supply Chain Integration, ADUSD (L&MR) SCI, authorized DLA and Marine Corps to proceed with development of procedures, including the cataloging data exchange, supporting materiel storage at less than the unit of issue and for issuance of non-NSN items using a local stock number for identification. Due to the policy implications of this change, the concept was presented to ADUSD (L&MR) SCI for approval subsequent to initial staffing. Although approving the unit of use concept in order to meet the Marine Corps-DLA timeline, SCI also requires exploration of an enterprise solution for future use.

(3) Procedures must be documented for inclusion in the DLMS manual (DOD 4000.25-M). **DLA HQ J-33 to provide procedures upon approval of requested change.**

e. <u>Detailed Procedure: Less than unit of issue request:</u>

(1) Marine Corps uses materials for production in less than FLIS unit of issue quantities. DLA will be required to maintain inventory at the less than unit of issue under a Distribution Standard System (DSS) unique material number for items which the Marine Corps uses at less than FLIS unit of issue. The material number will be treated as a LSN (Unit of Use) within DSS. All subsequent transactions against this material will be recorded under this 'unit of use' LSN within DLA systems. The LSN for Unit of Use will be derived from the NSN by modifying the first position of the NATO code to reflect an 'A' for Albany 'B' for Barstow, e.g., Albany NIIN = 011234567, LSN = A11234567. The Marine Corps will send DLMS 846A Asset Reclassification Request transactions to DSS to:

- (a) Convert NSNs and LSNs to 'unit of use' LSNs, in some cases resulting in the initial establishment of the 'unit of use' LSN; and
- (b) concurrently convert the entire on-hand balance for the NSN or LSN to the 'unit of use' LSN. Accordingly, for the MC generated 846A, a quantity to be converted is not required and is not specified in the transaction.

For initial establishment of the 'unit of use' LSN, DSS will establish the DSS Item Data Record using core FLIS data content and the unit of use contained in the 846A, and existing DSS LSN item record data for established LSNs

STAFFING NOTE on differing Navy and Marine Corps business rules for 'unit of use' LSN which DLA established under BRAC:

---Under Navy BRAC, initial establishment of 'unit of use' LSNs is only accomplished using DLMS 832N Catalog Data Support transaction¹. Only after the 'unit of use' LSN has been established by an 832N transaction, would an 846A Asset Reclassification Request transaction be used to convert from an NSN to a 'unit of use' LSN. Unlike Navy, the Marine Corps will establish 'unit of use' LSNs by sending DSS an 846A Asset Reclassification Request to convert NSNs to 'unit of use' LSNs. Additionally, unlike the Navy BRAC process which only converts NSNs to 'unit of use' LSNs, under the Marine Corps BRAC process, the Marine Corps will use the Asset Reclassification Request to convert LSNs to 'unit of use' LSNs.

---The Marine Corps 'unit of use' LSN construct will be similar to that used by the Navy for LSNs, but the Marine Corps will substitute an "A" (for Albany) or "B" (for Barstow), for example: **5975-A0-000-1234** (rather than the "U" used by the Navy). Unlike the Navy where there may only be one 'unit of use' LSN per NSN, the MCMC may assign one each for Barstow and Albany.

(c) All transactions exiting MCMC systems will reflect the Unit of Use Indicator, NSN, and the unit of use as applicable. All subsequent associated transactions exiting DSS to MCMC systems will reflect the 'unit of use' LSN and NSN, Unit of Use Indicator, Unit of Use as applicable. <u>STAFFING NOTE:</u> Under Navy BRAC, a "cross-reference NSN" was added to transactions using a 'unit of use' LSN and the associated Unit of Use Indicator. The "cross-reference NSN" was added by ADC 381 (see data element matrix in ADC 381). Since MC also converts LSNs to 'unit of use' LSNs, ADC 381A (reference 3h) adds the cross-reference LSN to transactions as applicable to support the MC process of converting LSNs.

(d) DSS will confirm re-identification has been completed with a 947I Inventory Adjustment with W1901 Quantity or Status Adjustment Reason Code 'AF-Stock Number Change' (Use to identify inventory adjustment gain or loss resulting from stock number change) (MILSTRAP DI Code D8K/D9K functionality).

(2) Once a MC 'unit of use' LSN is established/exists, DSS will convert and store any future receipt quantities of the parent NSN or LSN at the 'unit of use' LSN level, without the MC submitting an 846A. Material will always be receipted in DSS at the unit of issue since the MCMC purchased the material at unit of issue and it must be paid for at unit of issue. Once DSS receipts the material at unit of issue, DSS will determine if this stock is already being stored at unit of use. If it is DSS will perform the stow function to that location at unit of use. The MCMC systems also know if material is being stored at unit of use or unit of issue, and will automatically update their systems accordingly.

f. Asset Reclassification Denial Code. Use LQ01 qualifier 'ARD-Asset Reclassification Denial' code (defined under ADC 376).

(1) The Asset Reclassification Denial code is used in conjunction with an Asset Reclassification Denial Transactions. If the Asset Reclassification Request is denied, the only requirement for the MC is to wait and resubmit the 846A request. If the MC knows the specific reason for the asset reclassification denial, depending on the criticality of the item, they can contact the DLA warehouse and request the specific action be completed.

¹ PDC 360A (reference 3f) addresses use of 832N to establish unit of use LSNs under Navy BRAC requirements. PDC 360B (reference 3g) addresses Marine Corps BRAC requirements for 832N.

(2) Request multiple iterations of LQ01 'ARD' be authorized for use per Asset


