#### 4. APPROVED CHANGE(S):

**a. Brief Overview:** This change modifies the DLMS 824R to expand the scope to include rejection of logistics bills and make administrative adjustments to convert the

supplement into an implementation convention (IC) and to reflect current element use by DLA Transaction Services. Significant modifications to this DLMS change since staffing the PDC are highlighted in green.

## b. Background:

- (1) DLMS 824R was initially developed for rejection of DLMS transactions associated with MILSTRAP providing legacy Document Identifier Code DZG functionality, with specific reject advice codes. However, the 824R scope was expanded under the DLMS concept of operations and was authorized for use with other DLMS supply transactions (Reference 3.a.). In practice, it was also being used for DLMS Finance transactions with narrative messages citing the reason for rejection. DLMS 824R is specifically intended to be used by DLA Transaction Services for narrative message type rejects for DLMS transactions subject to rejection by Defense Automatic Addressing System (DAAS) narrative messages, as well as coded rejects using the Reject Advice Code in the 2/LQ/086 segment.
- (2) This change was developed concurrent to ADC 1043A (Reference 3.b.). ADC 1043A defines the DLMS 824R as the common means for communicating when a DLMS transaction fails a new edit established under ADC 1043 (reference 3.c.), relevant to specific supply and finance DLMS transactions.
- **c. Procedures, Transactions, Data Elements, and Processing Details in Use Today** (**Finance**): Logistics Bills, DLMS 810L (MILSBILLS legacy DIC F-series/G-series), are rejected by returning the rejected bill with a narrative reason for rejection. DLA Transaction Services rejects bills using the DLMS 824R with the appropriate narrative, but there are no rejection code qualifiers to facilitate automation and analysis and use of DLMDS 824R was not previously documented in DLMS for this purpose.. DLA Transaction Services also includes a one record position reject reason code in RP 4 of the legacy Summary Bill and in MILSINQ. Currently used codes and reasons for rejection include:
  - V Unauthorized "Bill To"
    - ADDR BILL TO NOT AUTHORIZED FOR INTERFUND USE
    - BILL OFC ADDR NOT AUTHORIZED FOR INTERFUND USE
    - VALIDATE VALUE OF FE/GE ENTRY
  - W F3885 Not Authorized
    - ACCOUNT UNAUTHORIZED FOR USE IN INTERFUND BILL
  - X Dollar Value Summary not equal to Details
    - DOLLAR VALUE OF DETAIL NOT EQUAL TO SUMMARY
  - Y Card Count Summary not equal to Details
    - DOC COUNT NOT EQUAL TO COUNT IN RP 5-7 OF SBR

#### Z - Invalid "Bill To"

- BILLING ADDRESS IN RP 30-35 NOT IN DAAS RECORDS
- ADDR BILL TO IS INVALID FOR DOCUMENT ID

**STAFFING NOTE:** DLA Transaction Services has shortened all legacy transaction reject narratives to a maximum of 53 characters to accommodate internal DLA Transaction business processes. For example, MILSBILLS reject narrative for reject code Y was changed from "DOC COUNT NOT EQUAL TO COUNT IN RP 5-7 OF SUMMARY BILL" to "DOLLAR VALUE OF DETAIL NOT EQUAL TO SUMMARY". It was not anticipated that these changes impact legacy systems; however, Components were asked to identify any known potential impacts. No impacts were reported during staffing.

#### d. Approved Change in Detail:

- (1) Document finance as within the scope of the 824R and the existing narrative messages.
- (2) Establish Reject Advice Codes BV, BW, BX, BY, and BZ to accommodate current reasons for rejection of the DLMS 810L, Logistics Bill.
- (3) Document the existing capability at DAAS to reject finance transactions using DLMS 824R with narrative messages.
- (4) In accordance with new DLMS naming conventions, update previous references to "DLMS Supplements" with "DLMS Implementation Conventions".
- (5) Transition notes from Federal Notes to DLMS Notes as appropriate and remove all Federal Notes.
- **(6)** Document current usage of BGN04 and BGN05 by DLA Transaction Services.
- (7) Document transaction rejection applicability to supply transactions (MILSTRIP/MILSTRAP) in DLM Supply Volume.

#### e. Revisions to DLM 4000.25 Manuals:

- (1) Modify DLM 4000.25, Volume 1, Chapter 4 to better represent existing procedures and to indicate that the 824R is applicable to DLMS finance transactions.
- "C4.2.2. Reject-Error Routing. Routing of the reject is from the rejecting activity to the sending activity. This will typically lead to one of two scenarios:
- C4.2.2.1. DLA Transaction Services Transaction Reject. In this case Defense Automatic Addressing System (DAAS) shall uses the DLMS 824R, Reject Advice Transaction,

to report the error back to the originating activity, which must correct and retransmit the transaction.

- C4.2.2.1.1. The Reject Advice Transaction reports the unique document number of the erroneous transaction *and/or other pertinent information to identify the erroneous transaction* including reject advice codes (when available) identifying one or more specific error conditions.
- C4.2.2.1.2. Where specific reject advice codes are not established to identify the error condition causing the transaction to fail, DLA Transaction Services uses the DLMS 824R to provide narrative message rejection of any DLMS transaction using procedures described in paragraph C4.2.4.2.
- C4.2.2.1.3. A combination of reject advice codes and clarifying narrative may be used to facilitate interpretation of the error condition.
- C4.2.2.2. Activity Transaction Reject fromto DAAS. A potential future enhancement will allow aAn activity receiving a transaction from DAAS shall report the error back to the transaction originator using DLMS 824R. Under the planned enhancement DAAS shall will compare the rejected information to an image of the transaction as they received it from the originating activity. If DAAS determines it caused the error, DAAS shall will correct and retransmit the transaction. If DAAS determines the originating activity caused the error, then DAAS shall will initiate another Reject Advice Transaction back to the originating activity, as in the first scenario.
- C4.2.3. <u>Application Program Use of DLMS 824R</u>, <u>Reject Advice</u>. If a DoD Component application program cannot process a received transaction, it <u>shallwill</u> send a DLMS 824R, Reject Advice Transaction back to the sending activity. The Reject Advice Transaction reports the unique document number, <u>and/or other pertinent information to identify of</u> the erroneous transaction, and codes identifying one or more specific error conditions.

#### C4.2.3.1. Rejection by Specific Reject Advice Code

- *C4.2.3.1.1* Initially, DLMS 824R was developed to provide the functionality of legacy Military Standard Transaction Reporting and Accountability Procedures (MILSTRAP) Document Identifier Code (DIC) DZG, Transaction Reject. As such it rejects the following DLMS transactions with legacy MILSTRAP functionality: DLMS Transactions 527D, 527R, 536L, 830R, 830W, 846A, 846D, 846F, 846I, 846P, 846R, 846S, 867D, 867I, 870L, 888I, and 947I, citing specific reject advice codes in the LQ segment.
- **C4.2.3.1.2.** Additionally, the DLMS 824R is authorized for use with other DLMS supply (including MILSTRIP transactions), finance, and contract administration transactions that are not specifically identified in this chapter.
- *C4.2.3.2*. However, u*U*se of DLMS 824R does not supersedereplace procedures for error identification addressed by DLMS 140A, Small Arms and Light Weapons (SA/LW), DLMS 870S, Supply Status, or DLMS 842A/R, DoD Supply Discrepancy Report Reply. DLMS 824R codes may be expanded in the future as requirements are identified and implemented.

C4.2.3.2. <u>DAAS Rejects</u>. <u>DLA Transaction Services uses the DLMS 824R to provide narrative message rejection of any DLMS transaction as described in paragraph C4.2.4.3.</u>

#### C4.2.4. Characteristics of Use

- C4.2.4.1. <u>Application Identified Error Examples</u>. Even with stringent editing performed by the EDI translator, some error conditions will occur that only the more complex application program edits can identify. These errors may include:
  - C4.2.4.1.1. Invalid item identification.
  - C4.2.4.1.2. Quantity of zero when a nonzero quantity is required.
- C4.2.4.1.3. Invalid DLMS code received in the LQ02 Segment. The DLMS 824R applies only when a received transaction fails to comply with the application-level rules/formats specified in the <del>DLMS Supplement-implementation convention</del>.
- C4.2.4.2. <u>Violations of DoD Business Process Rules Where Reject Advice Codes Are</u> Identified
- <u>C4.2.4.2.1. Exceptions.</u> DLMS 824R does not apply when specifying violation of an internal DoD Component or activity business policy.
- C4.2.4.2.2. <u>Reporting</u>. Receivers of transactions containing these types of errors shall report the errors back to the sender using the DLMS Supplement specified in the appropriate functional volume. Frequently, the same DLMS Supplement number used in the erroneous transaction set is also used to report back the errors.
- C4.2.4.2₃. <u>DLA Transaction Services <del>Receipt and Generation of DLMS 824R Reject Advice"</del></u>

#### *Renumber subparagraphs of current C4.2.4.3. to C4.2.4.2.*

- (2) Revise DLM 4000.25, Volume 2, Chapter 1 to document applicability of DLMS 824R to the supply functional area and update table of contents.
- "C1.9 TRANSACTION REJECTION. DLMS Volume 1, Chapter 4 prescribes the procedures for the use of the DLMS 824R Reject Advice Transaction to exchange information about functional errors not covered by DLMS status or other type of supply transaction, including MILSTRIP and MILSTRAP functional areas. The Reject Advice Transaction reports the unique document number, and/or other pertinent information to identify the rejected transaction, and codes identifying one or more specific error conditions. Where specific reject advice codes are not established to identify the error condition causing the transaction to fail, DLA Transaction Services may use the Reject Advice Transaction to

provide narrative message rejection of the erroneous DLMS transaction. A combination of reject advice codes and clarifying narrative may be used to facilitate interpretation of the error condition."

- (3) Modify DLM 4000.25-2, MILSTRAP Appendix 2.8 Reject Advice Codes to include codes supporting existing DAAS logistics bill reject codes.
- BV Rejected. DoDAAC in the transaction does not have the appropriate authority code for its intended use
- BW Rejected. Suspense account is not authorized for Interfund use
- BX Rejected. Total dollar value detail of bills is not equal to total dollar value of the summary bill
- BY Rejected. Count of detail bills is not equal to the count in the summary bill (MILS RP 5-7, DLMS 810L 3/CTT01/070)
- BZ Rejected. DoDAAC is not valid in DAAS
- (4) Modify DLM 4000.25, Volume 4, Appendix 2.11 to add a listing for "Reject Advice Code" with DLM 4000.25-2 as the authoritative source.
- (5) Modify DLM 4000.25, Volume 4, Chapter 2 to document use of DLMS 824R to reject logistics bills.
- C2.2.3.2.6. DLA Transaction Services will reject bills when they fail any of the edits. See Chapter 6.2 for information about the routing and editing of bills processed through DLA Transaction Services. *Rejected bills will be reported back to the originating activity using DLMS 824R (Reject Advice Transaction) citing the applicable Reject Advice Code from DLM 4000.25-2, MILSTRAP, Appendix 2.8.* Rejected bills *may include* will be returned to the originating communications center with a narrative description indicating the reason for rejection *in addition to the Reject Advice Code*. Billing offices will correct the rejected bills and resubmit them to the DLA Transaction Services. Billing offices will ensure that all appropriate adjustments for rejected billings and interfund collections are made to seller accounting records.
- (6) Revise DLM 4000.25, Volume 4, Chapter 6 to document use of DLMS 824R as the transaction for DAAS to report back rejected bills to the originator or originating communications center:
  - "C6.2.2. Bill Editing and Billed Error Rejection
    - C6.2.2.1. DAAS shall will edit and reject any bill that fails any of the following edits:
    - ....[intervening text not shown]
- C6.2.2.2 Rejected bills will be reported back to the originating activity using DLMS 824R (Reject Advice Transaction) citing the applicable Reject Advice Code from DLM

4000.25-2, MILSTRAP, Appendix 2.8. Rejected bills shall be returned to the originator or originating communications center and may include a narrative description indicating the reason for rejection in addition to the Reject Advice Code. In addition, the second record position of the Reject Advice Code will be inserted in rp4 of the MILSBILLS legacy DIC FS\_/GS\_Summary Bill and displayed in MILSINQ, hyperlinked to the narrative reason for rejection."

(7) Update DLM 4000.25 Volume 4, Appendix 3 Record Format:

- (8) Revise DLMS 824R as shown in Enclosure 1.
- f. Alternatives: None identified.
- g. Proposed DLMS Change (PDC) 1103 Staffing Response/Comment Resolution: Concurrence and resolution of comments is shown at Enclosure 2.
- **5. REASON FOR CHANGE:** Documents expanded use of DLMS 824R to reject logistics bills for functional business rules reasons, administrative updates, and clarification of procedures and use.

#### 6. ADVANTAGES AND DISADVANTAGES:

- **a. Advantages:** Formally documents the approach for reporting rejections of finance using narrative message and enables the use of the coded means for better analysis.
  - **b. Disadvantages:** None identified.

- **7. ESTIMATED TIME LINE/IMPLEMENTATION TARGET:** Staggered implementation will be permitted after DLA Transaction Services target implementation to support September 30, 2014 SLOA implementation.
- 8. ESTIMATED SAVINGS/COST AVOIDANCE ASSOCIATED WITH IMPLEMENTATION OF THIS CHANGE: None identified.

#### 9. IMPACT:

- **a. DLMS Data Elements/LOGDRMS**: Update Reject Advice Codes as described above.
- **b.** Automated Information Systems (AIS): DLMS-compliant Service systems must be able to receive/create the 824R Reject Advice as documented in this ADC. Applicable to supply and finance systems.

#### c. DLA Transaction Services:

- (1) Since reject advice codes are two character codes, DAAS will have to program for MILSINQ to ignore the first character in inserting the reject code in rp 4. The second character of the reject advice codes are the same as the existing single character codes used at DAAS.
- (2) Update mapping for DLMS 824R according to changes to the REF and LQ segments as shown in Enclosure 1.
