- **3. REFERENCES:** DLM 4000.25, Defense Logistics Management System (DLMS), Volume 6, Chapter 2, Department of Defense Activity Address Directory.
- 4. APPROVED CHANGE: (Changes from PDC 1148 highlighted in yellow)
- **a.** <u>Brief Overview of Change</u>: This change will only impact the eDAASINQ application. There are two required actions: 1) create a report to track orphaned Routing Identifier Codes (RIC), and 2) move the City/ZIP error report from its current location on the "Downloads" page to a new "reports" section.
- **b.** <u>Background</u>: eDAASINQ contains a link to "Downloads" in order to download extracts from the DoDAAD database. The one exception is the United States Postal Service (USPS) file, which is actually an error report listing of invalid city names and/or Zone Improvement Plan (ZIP) codes. This change is to move the invalid city/ZIP report from "Downloads" to a new "Reports" section. This area on the page is to be added below the "Downloads" links. In addition, we are requesting two new reports be created for RICs to report on 1) RICs that are associated with deleted DoDAACs and 2) RICs where the address lines do not match the corresponding address lines within the DoDAAC.

c. Describe Change in Detail:

- (1) On eDAASINQ, DLA Transaction Services will rename the existing "Downloads" link on the left side of the page to "Downloads and Reports".
 - (2) Change the page header from "Downloads" to "Downloads and Reports".
- (3) Change the sub-header "There are 4 file downloads available. Please select from the links listed below" to "Downloads available:".
 - (4) Add a new sub-header "Reports Available:".

- (5) Move "Download USPS File" under new "Reports Available:" sub-header and rename link to "City/ZIP Error Report".
- (6) On the current "USPS Download" page, rename "USPS Download" to "City/ZIP Error Report" and remove the "month" selection, because only a link to the most current version is required. The report should be refreshed daily. No history of the prior month's version is required.
- (7) Change the format of the City/ZIP Error Report to an Excel spreadsheet. Each line should contain all the information for the TAC reported, as opposed to the current format. New format and field order should be as follows:
 - (a) Error message (e.g., Invalid City)
 - (b) DoDAAC
 - (c) MAJCOM
 - (**d**) TAC (i.e., 1, 2, 3 or 4)
 - (e) Address lines 1
 - **(f)** Address lines 2
 - (g) Address lines 3
 - (h) Address lines 4
 - (i) City
 - (j) State
 - (**k**) ZIP (with plus 4, if applicable)
- (8) Add a new report link for "Orphaned RICs" under the new "Reports Available:" sub-header. The criteria for the Orphaned RICs is:
- (a) Select all active RICs where the associated DoDAACs contains a delete date in the TAC 1 or no DoDAAC exists (i.e., not listed or not found).
- **(b)** Report will contain: RIC, DoDAAC associated with RIC, and DoDAAC delete date on the TAC 1.
- (c) The report should be generated daily and overlay the previous copy, so it will always contain the latest information.
 - (d) The download of the report should be in Excel format.
- (9) Add a new report link for "Mismatched RICs" to the new "Reports Available:" sub-header. The criteria for the Mismatched RICs is:

- (a) Select all active RICs where the City, State and Country data in the RIC does not match the corresponding City, State and Country data in the TAC 1 of the associated DoDAAC.
- **(b)** Report will contain: RIC, DoDAAC associated with RIC, and a message to indicate the field or fields (i.e. City, State and/or Country) that do not match.
- (c) The report should be generated daily, so it will always contain the latest information.
 - (d) The download of the report should be in Excel format.
- (10) The CSPs should review both reports at least once a month and correct any errors found during the review process. This needs to be done to ensure data quality for data maintained within the DoDAAD.
 - d. <u>Revisions to DLM 4000.25 Manuals</u>: None required.
