#### 4. APPROVED CHANGE:

a. <u>Brief Overview of Change</u>: This change modifies the Defense Logistics Manual (DLM) 4000.25 (reference 3.a.) and DLM 4000.25-2 MILSTRAP (reference 3.b.) definition of Small Arms/Light Weapons to include suppressors. Discussions held during the annual JSA/LWCG meeting indicated that the majority of members believe suppressors should be DOD-reportable due to the Security Risk Code. This correction replaces the Navy specific policy with the broader DOD policy to better reflect applicability across the DOD. The corrections to sections 3. and 4. are highlighted green. There are no changes to the approved procedures delineated by ADC 1147.

## b. Background

- (1) Reference 3.c., DODM 5100.76, states in Enclosure 7, paragraph 3.a.(3), defines "weapons components such as silencers, mufflers, and noise suppression devices" as Security Risk Category II items. And Enclosure 11, paragraph 2.c.(6) requests DOD Components "determine additional item reporting requirements based on the sensitivity and potential threat posed by items. These items may include but are not limited to silencers, mufflers, noise suppression devices, and/or sniper rifle systems." The Navy considers Category II small arms as DOD-reportable; therefore, this request is to add noise suppressors to the DOD small arms definition, which would in turn make them reportable to the DOD Registry.
- (2) Per Reference 3.d., the US Code on Firearms, Title 18, Section I, Chapter 44, (Firearms), Section 921 (Definitions), Paragraph (a) (3), the definition of small arms as written in law is:

"The term "firearm" means:

firearm."

- (a) Any weapon (including a starter gun) which will or is designed to or may readily be converted to expel a projectile by the action of an explosive;
  - **(b)** The frame or receiver of any such weapon;
  - (c) Any firearm muffler or firearm silencer; or
  - (d) Any destructive device. Such term does not include an antique
- (3) The need to update the DOD small arms definition used for DODSASP has been raised at JSA/LWCG meetings to support the changing environment for maintaining visibility and reporting of suppressors within the DOD.
- (4) Suppressors are highly pilferable and cataloged as a Controlled Inventory Item Code (CIIC) 2, the definition being "High Sensitivity (Category II) Arms, Ammunition, and Explosives."
- c. <u>Describe Approved Change in Detail</u>: In order to support DOD mandated Small Arms Serialization Program and will transition to unique item identification tracking, appropriate wording is added to the Small Arms and Light Weapons definition in References 3.a. and 3.b. that will include associated noise suppression devices and silencers into the definition. This supports

the changing environment for DOD Registries in order to maintain accountability and require reporting of suppressor serial number data within the DOD.

**d.** <u>Revisions to DLM 4000.25 Manuals</u>: Revise References 3.a. and 3.b. definitions of Small Arms and Light Weapons to include noise suppression devices as follows: (Note: Added text is indicated by bold italicized red text.)

"SMALL ARMS AND LIGHT WEAPONS. For the purpose of DoD small arms and light weapons reporting, small arms and light weapons are defined as man-portable weapons made or modified to military specifications for use as lethal instruments of war that expel a shot, bullet, or projectile by action of an explosive. Small Arms are broadly categorized as those weapons intended for use by individual members of armed or security forces. They include handguns; rifles and carbines; sub-machine guns; and light machine guns.

Light weapons are broadly categorized as those weapons designed for use by two or three members of armed or security forces serving as a crew, although some may be used by a single person. They include heavy machine guns; hand-held under-barrel and mounted grenade launchers; portable anti-aircraft guns; portable anti-tank guns; recoilless rifles; man-portable launchers of missile and rocket systems; and mortars.

Associated suppressors, silencers, mufflers, and noise suppression devices appropriate for previously listed small arms and light weapons are included and will be reported within the Component and DoD registries."

- e. <u>Approved Transaction Flow</u>: There are no revised transaction flows.
- **f. Alternatives:** None noted.
- **5. REASON FOR CHANGE:** This change is proactive in clarifying and defining small arms and light weapons to include suppressors in support of DOD tracking and reporting requirements. This change revises the definition and will enable the Components to address and fully comply with SA/LW DODSASP and transition to Unique Item Identifier (UII) tracking and reporting requirements within the DOD.

# 6. ADVANTAGES AND DISADVANTAGES:

- **a.** Advantages: This change supports the changing environment for maintaining visibility and reporting of suppressor serial number data within the DOD. It also supports the requirement for unique item level traceability for all DOD serially-managed items that are sensitive or pilferable, documented in DODI 4140.01, Supply Chain Materiel Management Policy, and DODM 4140.01 Volume 11, Management of Critical Safety Items, Controlled Inventory Items Including Nuclear Weapons-Related Materiel.
  - b. **Disadvantages**: None noted.
- 7. ADDITIONAL COMMENTS TO CONSIDER:

- **a.** Inter-service moves can result in accountability issues because not all DOD Components consider suppressors reportable items or track them by serial number. At this time, only the Navy and Marine Corps track suppressors as reportable items by serial number.
- **b.** The underlying issue is to determine what needs to be tracked in the DOD SA/LW Registry to support current law enforcement efforts. Support of law enforcement guidelines is one of the reasons the registry exists. We need to assess this requirement to determine the probability of law enforcement requesting DOD to trace the whereabouts of a firearm muffler or silencer, and to ensure that this probability supports the need to track mufflers and silencers in the DOD Registry.
- **c.** During the Joint Small Arms/Light Weapons Coordinating Group meeting of July 19<sup>th</sup>, 2002, a representative from Alcohol, Tobacco, Firearms, and Explosives (ATFE) pointed out that suppressors are included in their definition of small arms. This further validates the necessity of this request.
- **8. ESTIMATED TIME LINE/IMPLEMENTATION TARGET:** December 1, 2014.

# 9. IMPACT:

- a. New DLMS Data Elements: None identified.
- **b.** <u>Changes to DLMS Data Elements</u>: None identified; however, there may be a need to revise automated information systems data element coding and segregation as this change redefines SA/LW for DOD tracking and reporting requirements.
- **c.** <u>Automated Information Systems (AIS)</u>: DOD Components may need to revise automated information systems data element coding and segregation as this change redefines SA/LW for DOD tracking and reporting requirements.
  - d. DLA Transaction Services: None identified.
- **e.** <u>Federal Logistics Information System (FLIS)</u>: Components are required to ensure that items covered under the definition are assigned the UIT Designator Code "AAA" in FLIS.
- **f.** <u>Component Registries</u>: The Navy, Marine Corps and Coast Guard already track and record silencers and noise suppressors, however, for the Army and the Air Force, it will be necessary to initially register on-hand balances to their respective Service Small Arms Registry and to the DOD IUID Registry.
- **g.** Non-DLA Logistics Management Standards Publications: NAVSEAINST 8370.2D, Small Arms and Weapons Management Policy and Guidance Manual; MCO 8300.1D, Marine Corps Serialized Small Arms/Light Weapons Accountability Program (MCSSAAP); Silencers as defined in 18 U.S.C. § 921(a)(24) as must be registered and transferred in accordance with the National Firearms Act and the Gun Control Act of 1968, <a href="http://www.atf.gov/firearms/faq/national-firearms-act-firearms.html#nfa-firearms">http://www.atf.gov/firearms/faq/national-firearms-act-firearms.html#nfa-firearms
