## **2. REASON FOR CHANGE:**

**a. Bottom Line Up-Front:** This administrative change will remove the Defense Logistics Manual (DLM) 4000.25, Volume 2, Appendices 3.31 through 3.37 and update the Volume 2, Appendix 3 section of the table of contents and mark as “**RESERVED**.”

**b. Background:** Under Approved Defense Logistics Management Standards (DLMS) change (ADC) 1244B published April 22, 2022, the DLMS 140A Small Arms Reporting and DLMS 888A Small Arms Data Change transactions were sunset and are no longer available for implementation. However, during the development of ADC 1244B, several appendices were not included by mistake.
