- **a.** <u>Overview</u>: This change implements Agency Code 53, Institute of Museum and Library Services.

b. **Background**:

- (1) The Institute of Museum and Library Services currently resides under Federal Agency Code 59 (National Foundation on the Arts and the Humanities). The Department of the Treasury requested the Institute of Museum and Library Services be moved from Agency Code 59 to 53 in order to facilitate a clean report line and report data transparency.
- (2) The Common Government Accounting Classification Code (CGAC) of 474 will also need to be moved from Agency Code 59 (Other Independent Agencies) to Agency Code 53 (Institute of Museum and Library Services).
