4. APPROVED CHANGE(S): Significant changes from the PDC are highlighted in green.

a. **Brief Overview of Change:** This change:

(1) Eliminates the longstanding Defense Automatic Addressing System (DAAS) interim conversion of obsolete MILSTRAP Document Identifier Code (DIC) D6S transactions to

DIC DRA Material Receipt Acknowledgement transaction functionality. DAAS will no longer count any obsolete DIC D6S transactions as MRA transactions

(2) Discontinues DAAS production of the monthly D6S transaction report.

b. Background:

(1) As discussed at DLMS Supply PRC Meeting 16-1 (Reference 3.a.), Approved MILS Change Letters (AMCL) 11 and 15 (Reference 3.b.) revised the MRA procedures to eliminate the use of MILSTRAP DIC D6S for MRA. AMCLs 11 and 15 replaced DIC D6S with DIC DRA for the MRA transaction. To accommodate staggered implementation of the revised MRA procedures from 1997-1999, DAAS provided a temporary conversion of DIC D6S to DIC DRA (MRA). The intent was that DAAS would use this interim procedure until full implementation of AMCL 11 and 15 revised MRA procedures in the late 1990s. However, a monthly DAAS D6S report revealed that some Services continued to generate a significant number of D6S transactions into the early 2000s.

(2) In early 2016, an analysis of the monthly D6S report revealed that Army generated most of the remaining obsolete DIC D6S transactions. In particular, Headquarters, Joint Munitions Command Rock Island, generated the transaction to send to Army Logistics Modernization Program (LMP). In the June–July 2016 timeframe, the affected Army system(s) stopped producing the D6S transactions while the Army developed a system change to produce the appropriate MRA transactions. As a result, starting in July 2016, the D6S report showed no additional D6S transactions.

(3) PDC 1211 (Reference 3.c.) removes DIC D6S from DLMS Volume 6, Logistics Systems Interoperability Support Services; Chapter 4, Pipeline Measurement.

c. Approved Change in Detail:

(1) Eliminate DAAS interim conversion of obsolete MILSTRAP DIC D6S transactions to DIC DRA MRA transaction functionality.

(2) Discontinue DAAS monthly D6S transaction report.

d. Revisions to DLM 4000.25 Manuals: There are no revisions to the DLM 4000.25 series of manuals or to the DLMS implementation conventions.

e. Transaction Flow: No change to transactions flow.

f. Alternatives: None.

5. REASON FOR CHANGE: To eliminate the longstanding DAAS interim process established in the late 1990s to convert obsolete MILSTRAP DIC D6S transactions to the replacement DIC DRA functionality.

6. ADVANTAGES AND DISADVANTAGES:

a. **Advantages:** Eliminates use of DAAS resources to support an obsolete MILSTRAP transaction.

b. **Disadvantages:** None.

7. ESTIMATED TIME LINE/IMPLEMENTATION TARGET: Eliminating the interim DAAS requirements associated with obsolete DIC D6S is effective upon publication of the ADC.

8. ESTIMATED SAVINGS/COST AVOIDANCE ASSOCIATED WITH IMPLEMENTATION OF THIS CHANGE: None identified.

9. IMPACT:

a. **New DLMS Data Elements:** No new DLMS data elements.

b. **Changes to DLMS Data Elements:** No changes to DLMS data elements.

c. **Automated Information Systems (AIS):** USTRANSCOM to update the Strategic Distribution Database (SDDDB) to reflect MRA (or DRA/DRB) rather than the multiple incorrect D6S references.

d. **Defense Automatic Addressing System (DAAS):**

(1) Eliminate DAAS programming logic associated with converting DIC D6S to DIC DRA.

(2) Eliminate DAAS programming logic associated with producing the monthly D6S transaction report.

e. **Non-DLM 4000.25 Series Publications:**

(1) Components should ensure obsolete MILSTRAP DIC D6S transactions are not included in their Component level publications.

(2) DAAS update internal documentation as needed.
