- **4. REQUESTED CHANGE(S):** Significant changes subsequent to the PDC staffing are identified by green shaded text.
- **a.** <u>Brief Overview of Change</u>: Revise the MRA Report download capability to have an option to download the complete list of transactions by Component where an MRA was not

received (CONUS/OCONUS). This will apply to the MRA 02 Direct Vendor Delivery, MRA 36 Stock Shipment, and MRA 37 Direct Vendor Delivery and Stock Shipment Reports only.

b. **Background**:

(1) ADC 1086 (Reference 3.a.) updated the MRA Reports (Reference 3.b.) to add an option from the MRA Report Detail page (after selecting a DoDAAC) to download the entire list of reported document numbers with associated requisition/initial supply transaction data to an Excel file for additional research. The following data elements are included in the existing download file:

- Header with Date Run (Source of Supply RIC is included on selected existing reports)
- Shipment Date
- Document Number
- Suffix
- Supplementary Address
- Ship-To DoDAAC
- Signal Code
- Bill-To DoDAAC
- Priority
- NSN
- Shipped Quantity
- Unit of Issue
- Unit Price (U/P)
- Total Cost
- Initial Transaction DLMS/MILS, (e.g., requisition or initial supply transaction if no requisition is available per MRA Business Rules/Decision Tree)
- Communication Routing Identifier (COMMRI) of the system from which the requisition or initial supply transaction originated
- COMMRI associated with the Document Number DoDAAC, (e.g., could be a requisitioner/requiring/other activity)
- COMMRI where the Follow-up for Delinquent MRA transaction was transmitted
- (2) During meetings with the Office of the Deputy Assistant Secretary of Defense for Logistics (ODASD(Logistics)) led workgroup (Reference 3.c.), participants identified a requirement to expand the existing scope of the MRA download file. The data available in the existing download capability for the MRA Reports is by individual DoDAAC reported. The Services' representatives requested the capability to have the monthly download report available for all DoDAACs reported for each Service/Component on the current MRA Reports Tool.

c. Requested Change in Detail:

- (1) Modify the existing MRA Report download capability to include all DoDAACs for each "Customer" for the MRA reports: MRA02 (MRA 02d) DVD MRA Detail, MRA36 (MRA 36d) Stock Shipment Detail, and MRA37 (MRA 37d) DVD and Stock Shipment Detail.
- (a) This change will result in three additional download files by "Customer" (CONUS and OCONUS).
- **(b)** Enclosure 1 provides an example of the existing MRA Report for MRA 02, MRA 36, and MRA 37. This ADC does not change the existing MRA Report DoDAAC download file content identified in paragraph 4.b.(1).
- (2) Update the text in DLM 4000.25 DLMS, Volume 2 to reflect this change (See Enclosure 3)

d. Revisions to DLM 4000.25 Manual:

- (1) Volume 2, Chapter 10, paragraph C10.10. (See Enclosure 3).
- (2) DAAS Manual No updates are required.
- e. <u>Proposed Transaction Flow</u>: No changes are required to the MRA process.
- **f.** <u>Alternatives</u>: Users requiring the complete DoDAAC list currently need to select and save individual files, and merge them into a single file for analysis.
- **5. REASON FOR CHANGE:** Provides improved capability for MRA Report Tool users to conduct the MRA Report analysis required by Reference 3.b, paragraph C10.10. Management Evaluation.

6. ADVANTAGES AND DISADVANTAGES:

- **a.** <u>Advantages</u>: Provides users of the MRA Report Tool with an improved capability to conduct analysis of transactions by Component where an MRA was not received for a particular month.
 - b. **Disadvantages**: None
- **7. ASSUMPTIONS USED OR WILL BE USED IN THE CHANGE OR NEW DEVELOPMENT:** No changes are being made to the data content in the existing DoDAAC download reports or the MRA requirements. No system changes are required by any of the MRA users.

8. ESTIMATED TIME LINE/IMPLEMENTATION TARGET:

- **a.** DAAS: Report will be available three months from ADC release date.
- **b.** Components: No system changes are required.
- 9. ESTIMATED SAVINGS/COST AVOIDANCE ASSOCIATED WITH IMPLEMENTATION OF THIS CHANGE: Time savings were not calculated.

10. IMPACT:

- a. New/Changes to DLMS Data Elements: None
- **b.** <u>Automated Information Systems (AIS)</u>: No system changes for the MRA Report Tool users.
- **c.** <u>Defense Automatic Addressing System (DAAS)</u>: Requires updates to the MRA Report Tool per paragraph 4.c., and as noted in Enclosure 2.
- **d.** <u>Non-DLM 4000.25 Series Publications</u>: Components must update their local publications on MRA review procedures and incorporate changes as necessary to use the report documented in this change.



EBSO Comment: Each of the MRA reports has a "Save" button at the top of the page. When the cursor is placed on "Save" the user receives a popup message "Provide the current page data in CSV format". Based on Navy input, EBSO restructured the approach to generate the "Missing MRA Data" as shown in Enclosure 2. On the new Missing MRA Report selection window, DAAS will include a pop-up message "Provide the Missing MRA Data in CSV format"


By clicking on "Save Misising MRA Data" in the previous example, users will see the screen shown below. Selecting one of the links will return the respective Missing MRA Data combined report for the Service or Agency selected.

DAAS will include a popup message "Provide the Missing MRA Data in CSV format" when the cursor is moved over the links.



The report displayed will include the missing MRA data combined for CONUS and OCONUS.

A new column on the left side of the report will show C (CONUS) or (OCONUS) for each document number and will enable sorting/filtering the report by CONUS or OCONUS. See image below:

Make the following changes to Chapter 10 Materiel Receipt Acknowledgement.

C10.10. MANAGEMENT EVALUATION

C10.10.1. The DoD Components will establish a management evaluation program which monitors and evaluates MRA submission to ensure compliance with MRA requirements. Execute timely processing and perform response rate analyses to identify non-responsive activities and initiate corrective actions.

C10.10.2. The program will provide for:

C10.10.2.1. Review of the MRA Management Information report (Report Control Symbol DD-AT&L(AR)1419 applies). DAAS will prepare the report and provide access by electronic means. The report content is determined by the Supply Process Review Committee. Each Supply Process Review Committee representative is responsible for analysis of the report to identify potential deficiencies in their Service or Agency MRA operations or procedures contributing to breakdowns in internal controls for in-transit wholesale stock. Supply Process Review Committee representatives are responsible for initiating corrective action with delinquent and non-reporting activities.

C10.10.2.2. The MRA Management information report will include as a minimum:

C10.10.2.2.1. <u>General MRA Management Report Criteria</u>. Documentation of nonresponses for a reporting period to include: the number of qualifying shipments made to an activity (by "ship to" DoDAAC); the number of MRA responses received from that activity; the number of nonresponses. The following sections identify a common report description, how to do additional analysis of the data, and the types of breakdown to be available for MRA responses/non-responses for several different categories and whether detail by individual DoDAAC is available.

C10.10.2.2.2. Capability for Additional MRA Report Analysis

C10.10.2.2.2.1. Most of the MRA reports contain a "Save" link above the report title. Clicking the "Save" link launches the applicable MRA report content in a spreadsheet format for additional analysis

C10.10.2.2.2.2. The MRA reports contain an option from the MRA Report Detail page (after selecting a DoDAAC) to download the entire list of document numbers with associated requisition/initial supply transaction data to an Excel file for additional research.¹

C10.10.2.2.2.3. Three MRA Reports (MRA 02 Direct Vendor Delivery, MRA 36 Stock Shipment, and MRA 37 DVD and Stock Reports)

contain an option to download the entire list of document numbers for the missing MRA data shown on the Detail Reports page. Clicking the "Save Component Missing MRA Data" link will generate a list of Component options to download file for the missing MRA data and will combine the data for CONUS and OCONUS.²

C10.10.2.2.2.4. The following data elements are included in

- Header with Report Month or Date Run (depending on type of report) and
 - Source of Supply RIC included on the header for MRA38 (Source of Supply MRA Stock Summary), MRA39 (Source of Supply MRA DVD Summary) and MRA40 (Source of Supply Stock and DVD Summary)
- CONUS / OCONUS Indicator (MRA02, MRA36 and MRA37)
- Shipment Date
