Approved Defense Logistics Management Standards Change 1347D, Addendum to ADC 1347 Update to WebSDR Reply Rejection for Invalid Disposition Codes for Completion Notifications

2. REASON FOR CHANGE:

a. **Bottom Line Up-Front:**

- (1) This Addendum to ADC 1347 will update WebSDR with an edit to reject Supply Discrepancy Reporting (SDR) Replies (transaction code 11) submitted using Reply Codes 410-412 indicating that the SDR has been closed and no further action is required using the reply. Significant changes subsequent to staffing are in green shading.
- (2) Additionally, WebSDR will use SDR Rejection Reply Code 927- Transaction rejected. Missing or invalid disposition/reply code.
- **b.** <u>Background</u>: DEDSO was notified of invalid transactions when activities were submitting SDR replies (transaction code 11) with Reply Code 410-412 to indicate that the record was closed. However, current procedures state that only Completion Notifications (transaction code CN) transactions are authorized to use Reply Codes 410-412.

3. CHANGE IN DETAIL:

- **a.** <u>Technical Details</u>: DAAS will update WebSDR with an edit to reject any transaction code other than a CN utilizing Reply Codes 410-412.
- (1) WebSDR will use SDR Rejection Reply Code 927- Transaction rejected. Missing or invalid disposition/reply code.
- (2) WebSDR will insert remarks/narrative comments stating the following: Reply Codes 410-412 must only be used with Completion Notification (CN) transactions. Please resubmit your transaction.
 - **b.** Revised Transaction Flow: No change to the current DoD SDR process flow.
- **4. IMPLEMENTATION TARGET:** This change will be implemented upon approval.

5. TECHNICAL IMPACT:

- a. Additions or Changes to Data Elements: No updates.
- **b.** <u>Automated Information Systems (AIS)</u>: Component and Services SDR systems must be updated to not send Reply Codes 410-412 using SDR Replies (Transaction Code 11).

c. <u>Defense Automatic Addressing System (DAAS)</u>: DAAS will update WebSDR as detailed in paragraph 3.a.

Defense Logistics Manual (DLM) 4000.25, Volume 2, Supply Standards and Procedures

Make the following changes to Volume 2. Additions are shown in *red bold italics* and deletions shown in double strikethrough. Renumbering may be required.

Chapter 17, Supply Discrepancy Reporting

C17.3.12.1.2.6. Completion Notification.¹ The submitting system will use a completion notification, identified by Transaction Set Purpose Code CN or Completion Notification in the SDR reply, will be used by the submitter to communicate with the action activity that final action has been taken on an SDR requiring a materiel disposition action. The SDR system receiving the Completion Notification may close the SDR as well or keep it open for additional actions. Submission of a Completion Notification is required for all SDRs prepared by the submitter, with the exception of those clearly identified as being provided for information only and requiring no action activity reply (SDR Action Codes 1H or 3B only). Action Code 1H or 3B SDRs will automatically be placed into a closed status in WebSDR metrics. The Completion Notificationee may not be used to modify originally reported SDR data elements. The following sub-paragraphs provide more detailed information regarding Completion Notification processing.

C17.3.12.1.2.6.4. Under selected scenarios, the submitter will provide a Completion Notificationee without a response from the owner/manager when the SDR is automatically closed immediately after transmission. SDR Action Codes 1B (Materiel being retained) and 1G (Reshipment not required; item to be re-requisitioned) apply. A Completion Notificationee will be provided using Reply Code 410.

C17.3.18.1.2.13. WebSDR will reject with Reply Code 927 any transaction code other than a CN utilizing Reply Codes 410-412. with reply code 927 Completion Notification with a reply code other than 410, 411 or 412. The narrative rejection comments will state "Reply Code 410, 411 or 412 are the only authorized reply codes used with Completion Notification transactions."
