#### 4. APPROVED CHANGE(S):

**a.** <u>Brief Overview of Change</u>: This change establishes a new advice code that allows DLA major subordinate commands (MSCs) performing inventory control point (ICP) functions

to issue short-dated shelf life. OCONUS customers may requisition such materiel for immediate consumption. The new advice code would only be applicable to OCONUS requisitions.

# b. <u>Background</u>:

(1) OCONUS customers currently submit requisitions to the Enterprise Business Systems (EBS). EBS subsequently sends materiel release orders to one of DLA's distribution centers through the Distribution Standard System (DSS). The distribution centers determine if the requisitioned materiel is in serviceable condition and has sufficient shelf life in accordance with DODM 4140.27, Volume 1 (Reference 3.a.). If the materiel does not have sufficient shelf life, DSS flags the materiel and sends a materiel release denial to EBS.

(2) After receiving the materiel release denial, the MSC/ICP contacts the OCONUS customer to determine if they will consume the materiel immediately to fill an urgent need. Otherwise, the ICP places the requisition on backorder. If the customer accepts the materiel, they must agree to the requirements in DLA Distribution SOP 4145.95 (Reference 3.b.). This verification process requires manual action on the part of the MSC/ICP and the customer.

(3) Requirements per Reference 3.a.:

(a) Items with a shelf life code (SLC) of 24 months or greater issued to satisfy either FMS or OCONUS requirements will be in Supply Condition Code (SCC) A, with a minimum of 12 months shelf life remaining. Requisitioners have the option to waive the 12-month minimum by submitting exception requisitions.

(b) Items with an SLC of less than 24 months are not subject to the 12month minimum. However, they must be issued from SCC A assets unless the customer specifies that other than SCC A materiel is acceptable or the ICP designates a release from a specified material condition. OCONUS requisitions include the DLMS 511R Requisition transaction and legacy Military Standard Requisition and Issue Procedure (MILSTRIP) Document Identifier Codes A01, A02, A03, A04, and A05.

(4) The current process workaround was developed to assist customers in requisitioning stock that has a short dated shelf life remaining, with the customer acknowledging that they are willing to accept the materiel as-is because it is for immediate consumption. Reference 3.b. defines the current process for meeting the customer's demand for short-dated shelf life materiel for immediate consumption. Opening the materiel for usage negates shelf life and triggers service life. This manual process requires coordination between customer, MSC/ICP, and Distribution.

(5) Audit Readiness requirements per Reference 3.b. include:

- (a) acceptance of short dated shelf life materiel, and
- (b) shelf life dates on packaging labels may not match shelf life dates on

actual product.

**c.** <u>Approved Change in Detail</u>: This change adds new Advice Code 3G to DLM 4000.25, Volume 2, Appendix 7.15, Advice Codes (Reference 3.c.) as shown below:

REQUISITION TRANSACTION ADVICE CODES				
CODE EXPLANATION				
3G	For OCONUS requisitions only. Requisitioner will accept shelf life materiel with a minimum of 4 months shelf life remaining until expiration at time of issue/shipment from DLA Distribution Center. Supply Discrepancy Reports (SDRs) will not be accepted for expired materiel with the usage of Advice Code 3G.			

**d.** <u>**Revisions to DLM 4000.25 Manuals:**</u> Revise DLM 4000.25, Volume 2, Appendix 7.15, Advice Codes to include Advice Code 3G and the code explanation.

e. <u>Proposed Transaction Flow</u>: This change does not alter existing transaction flows.

**f.** <u>Alternatives</u>: The alternative is to continue executing the current manual process in Reference 3.b.

**5. REASON FOR CHANGE:** DLA Distribution requested this change to allow OCONUS customers to accept short-dated shelf life materiel without the need for manual intervention. The ability of the customer to provide this code eliminates the need for a manual verification process. The DLA MSCs/ICP would no longer need to contact the customer, and the customer would no longer need to provide response.

# 6. ADVANTAGES AND DISADVANTAGES:

**a.** <u>Advantages</u>: This change provides a systemic method for customers to requisition short-dated shelf life materiel. It also improves timely warfighter support through increased materiel availability. Finally, the new advice code will utilize shelf life materiel within its whole life and thereby save taxpayer dollars.

**b.** <u>**Disadvantages:**</u> Adding a new advice code will require system updates across the DOD supply chain. Using a new advice code to order short dated shelf life materiel will make an additional advice code unavailable since a requisition can only accommodate one at a time.

**7. ESTIMATED TIME LINE/IMPLEMENTATION TARGET:** Implementation of this change is effective upon approval and publication of the ADC.

# 8. ESTIMATED SAVINGS/COST AVOIDANCE ASSOCIATED WITH IMPLEMENTATION OF THIS CHANGE:

**a.** Avoidance: DLA estimates a full-time equivalent labor savings of \$43K a year at the MSC/ICP and distribution centers.

**b.** Savings: DLA estimates a \$12M annual savings achieved through utilizing shortdated shelf life materiel instead of disposing of it.

#### 9. IMPACT:

#### a. New DLMS Data Elements: None

**b.** <u>Changes to DLMS Data Elements</u>: Update DLMS Qualifier 80, Advice Code to insert new code 3G as defined in paragraph 4.c. above.

c. <u>Automated Information Systems (AIS)</u>: DLA EBS, DLA DSS, and participating systems will require coding changes to generate and accommodate the additional advice code.

d. <u>Defense Automatic Addressing System (DAAS)</u>: No impacts identified.

e. <u>Non-DLM 4000.25 Series Publications</u>: DLA and participating Service/Agencies should update affected publications as needed.
