b. Approved DLMS Change (ADC) 246 Revise DLMS Supplement (DS) 527R and MILSTRAP Receipt Transactions to Document Use of Navy Materiel Turned Into Store (MTIS) Indicator (Supply/MILSTRAP)

4. APPROVED CHANGE(S):

a. **Brief Overview of Change:** This ADC withdraws ADC 246 in its entirety.

b. **Background:** ADC 246 was required to facilitate the DLA DSS partnership agreement with Navy Uniform Automated Data Processing System (UADPS) that created a MTIS receipt indicator of “S” in record position 7 on the DLMS 527R/D6 to identify the receipt transaction for retail assets of Navy Managed Ready for Issue (RFI) Depot Level Repairable, Fleet Level Repairable and DLA managed consumables. This change will omit the MTIS indicator as the Navy no longer requires this functionality.

c. **Approved Change in Detail:** Withdrawal of ADC 246 and remove the MTIS indicator from record position 7 of the legacy Document Identifier Code (DIC) D6_ and 2/N901/90 segment (1R qualifier) of the 527R Receipt as shown in Enclosure 1

d. Revisions to DLM 4000.25 Manuals: Revise DLM 4000.25, DLMS, Appendix 3.2, DIC Code D6_, Materiel Receipt – Other Than Procurement Instrument Source, to remove Footnote 1 related to Navy/DLA use of rp 7 for the MTIS indicator as shown below:

Revise DLMS Supplement (DS) 527R and MILSTRAP Receipt Transactions to Document Use of Navy Materiel Turned Into Store (MTIS) Indicator (Supply/MILSTRAP)

1. ORIGINATOR:

2. FUNCTIONAL AREA: Supply

3. REQUESTED CHANGE:

a. **Title:** Revise DLMS Supplement (DS) 527R and MILSTRAP Receipt Transactions to Document Use of Navy Materiel Turned Into Store (MTIS) Indicator (Supply/MILSTRAP)

b. **Description of Change:** When sending MILSTRAP Document Identifier (DI) Code D6_ receipt to the Navy, DAASC will send MTIS indicator in position 7 of the D6_ to the Navy if it contains an 'S'. This change incorporates the MTIS indicator in DLMS 527R receipt.

c. **Procedures:**

(1) Revise DS 527R Receipt as follows:

¹ Navy uses rp 7 for Navy Materiel Turned Into Store (MTIS) indicator ‘S’. The MTIS indicator identifies and allows completion of a receipt that was initiated through a unique MTIS Interface between DSS and Navy Uniform Automated Data Processing System (UADPS) II (U2). Navy use is documented in MILSTRAP for mapping purposes for conversion to DLMS in a mixed DLSS/DLMS environment. (See PDC 249.)

4. REASON FOR CHANGE: To facilitate DLA DSS partnership agreement with Navy Systems where the MTIS Receipt indicator is used by the Navy to indicate the receipt transaction for retail assets is being processed is a MTIS receipt. DLMS/MILSTRAP does not dictate retail receipt procedures, however the DOD Components may, and do, extend the DLMS/MILSTRAP transactions to retail use. This change addresses a code Navy requires in DLMS to support their current receipt processing.

BACKGROUND: MTIS in the broad sense refers to the process of turning in, screening, identification financial process and crediting for customer turn-ins of Navy managed Ready for Issue (RFI) Depot Level Repairable, Fleet Level Repairable, and DLA managed consumables. In the context of this PDC, MTIS refers to the process of turning into the DLA Distribution Depot (DD), retail, consumable items owned by the Navy, managed by DLA and the interface between DSS and the Navy Uniform Automated Data Processing System (UADPS) II (U2) System. This interface is only in place at the DDs collocated with a Navy Fleet Industrial Supply Center (FISC). When a receipt for MTIS is processed at a DD, the D6_ receipt is sent to U2, using a Customer Information Control System (CICS) interface which allows the D6_ to be sent on-line to U2. Navy currently enters the MTIS code in rp 7 of DI Code D6_, however in the future, the Navy MTIS indicator will be included in receipts that pass through DAASC and which process as DLMS 527R. Accordingly DLMS 527R requires revision to accommodate the Navy MTIS indicator.

5. ADVANTAGES AND DISADVANTAGES:

a. Advantages: This change is required for both DSS and Navy systems to run properly and support an existing Navy requirement and interface that has been in place for many years.

b. Disadvantages: If the change is not implemented, this will have an adverse effect on both Navy and DLA systems for existing processing.

a. Publication(s): Changes to MILSTRAP and DLMS 527R as noted in this PDC.

b. Perpetuate to DLMS XML and DOD XML receipt construct.
