4. APPROVED CHANGE(S):

a. **Brief Overview of Change:** This administrative change will convert and/or combine existing Federal Notes to DLMS Notes within the current DLMS Implementation Conventions (IC) as appropriate (Reference 3.a.) and delete Federal Notes. This change will also revise some existing DLMS Notes to reflect consistent wording and update DLMS ICs that contain weblinks. This administrative ADC does not change, eliminate, or add any new procedures.

b. **Background:**

(1) In the 1990s and early 2000s, EBSO participated in the DoD EDI Standards Management Committee (EDISMC) which was a part of the Federal EDI Standards Management Coordinating Committee (FESMCC). Under FIPS 161-2 (Reference 3.b), the goal of the FESMCC was to ensure a single Federal Government face to industry and its partners in the use of EDI, consistency among instances of an application across agencies, streamlined data, and coordinated Government representation at standards bodies. Functions of the committee included harmonizing development of EDI transaction sets and message standards among Federal agencies, and the setting of Government-wide implementation conventions for each EDI application used by Federal agencies.

(2) During this time, EBSO developed DoD Logistics ICs as supplements to overarching Federal ICs and contributed to the development of Federal ICs. In the 2000s, the Business Transformation Agency (BTA) absorbed the EDISMC, and the FESMCC was eliminated due to funding cuts. In September 2008, FIPS 161-2 was cancelled and in 2015, an updated DoDD 8190.01E (References 3.c.) was issued to reflect the status. After these developments, EBSO continued to release revised versions of DLMS ICs to the BTA, until the BTA was re-organized, and the FedBiz website was no longer maintained.

(3) EBSO no longer maintains Federal ICs and has regularly removed Federal notes from DLMS ICs as part of the ongoing change process. Additionally, several DLMS Notes within the IC will be standardized under this administrative change.

c. Approved Change in Detail:

(1) Update the DLMS ICs identified in the Enclosure by removing Federal notes and/or converting/combining the Federal notes to DLMS notes.

(2) Throughout the DLMS ICs, revise the notes below for consistency:

Existing Note	“For DLMS use, only the following codes are authorized”
Revised Note	“The following codes are authorized”

(3) ADC 1305 updated the term, advance receipt information (ARI) to the more commonly used term, prepositioned materiel receipt (PMR). EBSO implemented this change throughout the Defense Logistics Manual (DLM) 4000.25 Volume 2 procedures, and in some sections of the DLMS 527D Due-in/Advance Receipt /Due Verification IC (Reference 3.e.). This change will complete the update from ARI to PMR throughout remainder of the 527D IC.

(4) Website references within the DLMS IC will be updated as necessary in the affected DLMS ICs.

e. Alternatives: None – Continued inclusion of separate Federal Notes is confusing to users and serves no practical use.

5. REASON FOR CHANGE: Eliminates Federal notes throughout the DLMS ICs, in addition to revising existing DLMS Notes to reflect consistent wording.
