# Use of Management Codes in DLMS 511R Requisition, 511M Requisition Modification and 869F Requisition Follow-Up (Supply)

#### 3. APPROVED CHANGE(S):

**a.** <u>Brief Overview of Change</u>: This change revises the DLMS 511R Requisition, 511M Requisition Modification, and 869F, Requisition Follow-Up Transaction to address United States Air Force (USAF) requirements for the usage of management codes (Reference 3.a. and 3.b., Enclosure 2).

**b.** <u>Background</u>: The USAF uses the management code in internal requisition, requisition follow-up, and requisition modifier transactions to further delineate the reason for the request/purpose for relocating materiel to assign the appropriate general ledger account. USAF repair and production contractors must submit requisitions citing a USAF approved management code or the requisition is rejected.

#### c. <u>Approved Change in Detail</u>:

(1) This approved change revises the DLMS 511R Requisition, 511M Requisition Modification and 869F Requisition Follow-Up to allow the USAF to use management codes for internal USAF customers as identified in the enclosures.

(2) USAF Management Codes A-L will be maintained within the Air Force, identified as follows:

USAF Management Code	Transaction Usage	Business Rule
А	511R, 511M, 869F	requesting serviceable materiel for an assembly contract.
С	511R, 511M, 869F	requesting materiel for a conversion or modification contract
D	511R, 511M, 869F	requesting materiel for a disassembly contract
Е	511R, 511M, 869F	requesting materiel for a reclamation contract
F	511R, 511M, 869F	requesting serviceable materiel for a production contract, and the contractor has no carcass asset to return for credit
G	511R, 511M, 869F	requesting materiel for a destructive test contract.
Н	511R, 511M, 869F	requesting materiel for a repair contract
J	511R, 511M, 869F	requesting serviceable materiel for a production contract, and the contractor has a carcass asset to return for credit.
L	511R, 511M, 869F	requesting materiel as a loan for either a repair or production contract.

#### d. <u>Revisions to Defense Logistics Manuals (DLM)</u>: No changes necessary.

#### e. <u>Approved Transaction Flow</u>: Process flow remains unchanged.

**4. REASON FOR CHANGE:** The USAF uses the management code in the requisition, requisition modifier, and requisition follow-up to further delineate the reason for the request received from USAF production/repair contractors and USAF Security Assistance customers. This delineation is used to associate the requisition to appropriate general ledger accounts.

#### 5. ADVANTAGES AND DISADVANTAGES:

a. <u>Advantages</u>: Allows the USAF to develop a DLMS compliant solution for the 511R, 511M and 869F functionality and allows for the continued delineation of the reason for internal USAF requisitions. Without this change, the USAF will not be able to accept the DLMS 511R, 511M and 869F transactions without serious impact to their repair and production contractors.

**b.** <u>**Disadvantages:**</u> Requires programming changes within Defense Automatic Addressing System (DAAS).

# 6. ASSUMPTIONS USED OR WILL BE USED IN THE CHANGE OR NEW DEVELOPMENT: None.

**7. ESTIMATED TIME-LINE/IMPLEMENTATION TARGET:** USAF plans to implement upon approval of the change.

#### 8. ESTIMATED SAVINGS/COST AVOIDANCE ASSOCIATED WITH

**IMPLEMENTATION OF THIS CHANGE:** This will allow the USAF to continue to receive requisitions from repair and production contractors. Without this change, the USAF will not be able to accept the DLMS 511R Requisition, 511M Requisition Modification, and 869F Requisition Follow-up transactions.

#### 9. IMPACT:

#### a. New DLMS Data Elements: None.

#### b. <u>Changes to DLMS Data Elements</u>:

(1) Updates management codes, identified in Enclosure 1 and DLMS Implementation Conventions, identified in Enclosure 2.

(2) This change will require LOGDRMS updates as identified in Enclosures 1

and 2.

**c.** <u>Automated Information Systems (AIS)</u>: This change is for intra-AF use only. There is no change or impact to other Component systems to include the DLA Distribution Standard System.

**d.** <u>Defense Automatic Addressing System (DAAS)</u>: Translate USAF management code on the following legacy document identifier codes (DIC) as shown:

Legacy DIC A0\_(Requisition) AM\_(Requisition Modification) to DLMS 511R/511M transaction when sending them to a DLMS compliant USAF system.

Revise DAAS MILS to DLMS mapping for legacy DIC A0\_ and AM\_, record position (rp) 72 as follows

Legacy DIC AT\_ (Requisition Follow-up) to DLMS 869F transaction when sending them to a DLMS compliant AF system.

Revise DAAS MILS to DLMS mapping for legacy DIC AT\_record position (rp) 72 as follows:
