### ADC 1406 Remove tabs from eDAASINQ

#### 3. PROPOSED CHANGE(S):

- **a.** <u>Brief Overview of Change</u>: This change merges the tabs (DoDAAC Information, Contract Information, POC Information, GSA Information, Notes) on the results page of eDAASINQ into one page.
- **b.** <u>Background</u>: The tabs were originally added to eDAASINQ to compartmentalize information. Core DoDAAC, contract, points of contact were added to negate the need for scrolling through all the information on one page. Information would be organized and quicker to access. This implementation did not meet the expectation. The tabs are loaded independently, so each time a tab is clicked the system must re-read the database and retrieve the information for that specific tab, making switching tabs slow and laborious. Having everything on one page is easier to navigate, print and review.
- c. <u>Change in Detail</u>: In the eDAASINQ, eliminate the tabs and display all the information on one page. The additional information from each existing tab should be added to the bottom of the current "DoDAAD Information" page, divided by section breaks matching the name of the existing tab (e.g., Contract Information). The order each section must follow is the current order of the tabs as they appear left to right (DoDAAD Information, Contract Information, CSP Information, GSA Information and Notes). The new format will look like the current "Print" page.
  - d. Revisions to Defense Logistics Manuals: No change to the manual.
  - e. Proposed Transaction Flow: N/A
  - **f.** Alternatives: N/A
- **4. REASON FOR CHANGE:** Improve navigation and reduce the time required to query DoDAAC records.
