#### Approved Defense Logistics Management Standards Change 1422 Add Procurement Instrument Identifier to the Catalog Data Support Transaction

#### 1. ORIGINATING SERVICE/AGENCY AND POC INFORMATION:

#### 2. REASON FOR CHANGE:

**a.** <u>Bottom Line Up-Front:</u> This change revises the Defense Logistics Management Standards (DLMS) 832N Catalog Data Support transaction and adds a new qualifier to identify the procurement instrument identifier (PIID) authorizing the contractor to perform on behalf of the government. This qualifier will be required when the originator of the DLMS 832N is a contractor.

#### b. Background:

- (1) When a contractor uses their own warehouse system of record, they are responsible for creating and providing accurate material master data to the appropriate government accountable property system of record (APSR).
- (2) When the contractor procures an item on behalf of the government, and the item of supply is not catalogued or lacks a material master record, the contractor must create a local stock number (LSN) for the item. The DLMS 832N Catalog Data Support transaction is the appropriate transaction to communicate the new LSN and other attributes in the master records to the APSR. However, this transaction doesn't support the PIID that authorizes the contractor to act on behalf of the government.
- (3) DoD Instruction 5000.64, Section 4.6., Data Elements, requires APSRs to record the government furnished property (GFP) authorizing contract when in business with a contractor inventory control point (ICP). To ensure APSRs can properly record items of supply under LSNs and in custody of a contractor, this change introduces the mandatory use of the PIID in the DLMS 832N for GFP.

#### 3. CHANGE IN DETAIL:

#### a. Technical Details:

(1) This change adds qualifier 6L – Agent Contract Number (2/REF01/0400) to the DLMS 832N Catalog Data Support Implementation Convention (IC) to enable contractors to identify the authorizing contract when transmitting material master records to the APSR. The qualifier 6L mirrors the DLMS 947I Inventory Adjustment transaction to ensure consistency.

- (2) Contractors must cite qualifier 6L and include the PIID when transmitting a DLMS 832N. When the PIID is missing or invalid, the APSR will reject the transaction and request re-transmission via the DLMS 824R Reject Advice transaction with Reject Advice Code AI "Rejected. PIID (contract number) call/order number, contract line-item number (CLIN), and/or sub-CLIN is invalid or blank" (2/LQ02/086). DoDI 5000.64 requires the authorizing contract when the originator is a contractor.
  - **b.** Revised Transaction Flow: This change does not impact the flow of transactions.
- **4. IMPLEMENTATION TARGET:** The Air Force will implement this change upon the release of the ADC. No other implementation target reported.

#### 5. TECHNICAL IMPACT:

- **a.** Additions or Changes to Data Elements: This change adds qualifier 6L to the DLMS 832N Catalog Data Support IC in 2/REF01/0400. See Enclosure 1 for details.
- **b.** <u>Automated Information Systems (AIS)</u>: This change applies to all contractors managing GFP. Air Force contractor ICPs and the Defense Property Accountability System (DPAS) will also be impacted (see Enclosure 2). No other system impact reported.

**Coordination Response Requirement:** PRC Representatives, include, with your response, a list of all systems impacted by this change, including the program office point of contact information (name, phone number, email) for each listed system.

**c.** <u>Defense Automatic Addressing System (DAAS)</u>: DAAS must update the DLMS 832N Catalog Data Support transaction mapping and routing rules to support the new qualifier.

END-TO-END TESTING REQUIREMENTS:** Proper testing must take place between, DoD Components, contractor ICPs, and DAAS before the changes in this document are implemented in a DAAS production environment. In addition, DAAS will capture the results and participants of the testing in a work order. Only DoD Components or contractor ICPs who have implemented the DLMS 832N and have successfully tested transmission with DAAS may use this functionality.



	Activity	Description	
1	Update asset item indicative detail	Contractor performs an inventory adjustment. Contractor transmits catalog data support Defense Logistics Management Standards (DLMS) 832N, including contract number and delivery order number (if applicable), through DAAS to Air Force Government Furnished Property (GFP) Accountable Property System of Record (APSR).	
2	Route GFM asset item indicative information	DAAS receives DLMS 832N, including contract number and delivery order number, and routes it to the Air Force GFP APSR	
3	Update GFP asset item indicative detail	Receive catalog data support transaction DLMS 832N that includes contract number and delivery order from DAAS, records transaction and associates the asset item to the contract number
