# **Approved Defense Logistics Management Standards Change 1429 Revise Defense Logistics Management Standards 856R 4030 Shipment Status Materiel Returns Transaction Update Code Associations for Transaction Type Qualifier (Supply)**

**1. ORIGINATING SERVICE/AGENCY AND POC INFORMATION:** Defense Enterprise Data Standards Office (DEDSO), Tonja Carter, [Tonja.Carter@dla.mil](mailto:Tonja.Carter@dla.mil).

## **2. REASON FOR CHANGE:**

**a. Bottom Line Up-Front:** This change corrects version 4030 of the Defense Logistics Management Standards (DLMS) 856R Shipment Status Materiel Returns transaction to use qualifiers FT - Federal Supply Classification (2/LIN02/0200) and 83 - Supply Condition Code (02/LQ01/3500) only in conjunction with Transaction Type Code RD - Returns Detail (01/BSN06/0200) instead of Status Reason Code W05 - Order Discrepancy (previously located in 1/BSN07/0200).

### **b. Background:**

(1) Approved DLMS Change (ADC) 353A, “Revised Procedures for Pre-positioned Materiel Receipt and Shipment Status for Retrograde and Directed Discrepant/Deficient Materiel Returns Including Corrected Time Standard for Security Assistance/Foreign Military Sales”, August 25, 2010, replaced qualifier W05 - Order Discrepancy (1/BSN07/0200) with the more generic qualifier RD - Returns Detail (1/BSN06/0200) in the beginning segment of the DLMS 856R 4030 Implementation Convention (IC), however, the DLMS 856R 4010 IC was not impacted by this change. Publication of the 4030 IC missed the updates of two code-level DLMS Notes referencing the now obsolete qualifier W05. Qualifier W05 identified order discrepancies when shipment status was related to the return of discrepant or deficient materiel. To provide additional information and details to support qualifier W05, two additional codes were added to the 2/LIN02/0200 data element in the 4010 version of the DLMS 856R.

## **3. CHANGE IN DETAIL:**

**a. Technical Details:** Version 4030 of the DLMS 856R IC must be updated to correct the business rules (syntax) for the use of below qualifiers to require Transaction Type Code RD (01/BSN06/0200) to be present in the beginning segment of the transaction and not the previously removed Status Reason Code W05.

(1) FT – Federal Supply Classification (2/LIN02/0200)

(2) 83 – Supply Condition Code (02/LQ01/3500)

**b. Revised Transaction Flow:** This change does not impact the flow of transactions.

**4. IMPLEMENTATION TARGET:** Implementation target will be determined based on inputs received from PRC representatives.

**5. TECHNICAL IMPACT:**

**a. Additions or Changes to Data Elements:** This change corrects the business rules (syntax) in the DLMS 856R 4030 IC. See enclosure for details.

**b. Automated Information Systems (AIS):**

(1) DoD Component systems may need to update business rules and/or logic if current business rules require validation and processing of the data elements updated from this change to the 4030 version of the transaction.

(2) Any DoD Component unique mapping will result in updates to applicable business systems.

(3) For DLMS 856R 4030 transactions in X12 EDI (and associated XML EDI) the following syntax rules must be followed.

(a) If 2/LIN02/0200 = FT is present, then 1/BSN06/0200 = RD is required

(b) If 2/LQ01/3500 = 83 is present, then 1/BSN06/0200 = RD is required

(c) If 2/LIN04/0200 = CN is present, then 2/LIN02/0200 = FT is required

**c. Defense Automatic Addressing System (DAAS):**

(1) Update DAAS processing and DAAS maps as necessary to only allow for the following codes to be present in DLMS 856R 4030 transactions when 1/BSN06/0200 = RD.

(a) FT – Federal Supply Classification (2/LIN02/0200)

(b) 83 – Supply Condition Code (02/LQ01/3500)

(2) Ensure proper translation occurs between versions 4010 and 4030 when routing DLMS 856R transactions with qualifiers FT and 83. Version 4010 of the DLMS 856R still requires qualifier W05 – Order Discrepancy (1/BSN07/020) to be present when 2/LIN02/020 = FT and 2/LQ01/350 = 83. The DLMS 856R 4010 IC does not include qualifier RD as an available code in 1/BSN06/020.

**6. PUBLICATION/POLICY IMPACT:**

**a. Defense Logistics Manual (DLM) 4000.25:** No impact on DLM 4000.25. See the enclosure for DLMS 856R 4030 IC revisions.

**b. Non-DLM 4000.25 Publications:** Service/Agency publications may require updates.
