ADC 1438 Administrative Update to Revise DLMS 945A N1 Attributes to Used -MFR

2. REASON FOR CHANGE:

a. Bottom Line Up-Front:

- (1) This change revises the attributes of elements N103 and N104 to "used" in the implementation convention (IC) for version 4030 of the DLMS 945A Materiel Release Confirmation transaction.
- (2) There are no immediate system impacts. The DLMS 945A (4030) IC and associated XML schema will be updated and published upon release of this change. Components are encouraged to update their transaction mapping at the next available opportunity.
- **b.** <u>Background</u>: During the implementation of the Warehouse Management System (WMS), DLA encountered some problems using the N1 segment in the DLMS 945A Materiel Release Confirmation. The N103 and N104 elements in the N1 segment in position 2/N1/0800 are required, even though the syntax rules allow these to be optional. When using qualifier Z7 Mark-for Party, N102 will contain a full text address and therefore N103 and N104 are not necessary. This was an oversight when developing Approved DLMS Change (ADC) 1009A (Reference).

3. CHANGE IN DETAIL:

- a. Defense Logistics Manual (DLM) 4000.25: No impact.
- **b.** <u>Implementation Conventions (IC)</u>: Revise the DLMS 945A (4030) Materiel Release Confirmation IC as shown in the enclosure.
 - c. <u>Data Elements</u>: No impact.
