Approved Defense Logistics Management Standards Change 1439 Administrative Update to DLMS 842AW Implementation Convention

2. REASON FOR CHANGE:

a. <u>Bottom Line Up-Front</u>: This update to the 842AW transaction removes an incorrect "Must Use" requirement from the 2/LIN/0200, 2/DTM/0600, and 2/REF/0700 segments.

b. <u>Background</u>: ADC 1439 updated the LIN, DTM, and REF segments making them mandatory ("Must Use") in every HL Loop when they should be "Used". This disconnect was found during Defense Automatic Addressing System (DAAS) testing the new schema. With this "Must Use" requirement in place, they cannot validate any 842AW transactions received that includes unique identifier (UID) data. This amendment fixes this disconnect.

3. CHANGE IN DETAIL:

- a. <u>Technical Details</u>: Update the 842AW DLMS IC as shown in the enclosure.
- b. <u>Revised Transaction Flow</u>: Standard SDR process flow applies. No change.
