Approved Defense Logistics Management Standards Change 1441 Add New Transaction Origination Code to Defense Logistics Management Standards 888W Weapons System Data Change

1. ORIGINATING SERVICE/AGENCY AND POC INFORMATION:

2. REASON FOR CHANGE: Significant changes after staffing the proposed change are in green shade

- a. <u>Bottom Line Up-Front</u>: This change adds a new Transaction Origination Code (TOC) "Z" to the DLMS 888W Weapon System Support Program (WSSP) transaction. Navy Enterprise Resource Planning (ERP) will replace the Supply Support Request (SSR) processes for the Navy. Navy ERP will create the Weapon Item Data Transaction (WS1) to DLA requesting Weapons System Data Change (WSDC) and essentiality code assignment to the National Stock Number (NSN) for Naval Inventory Control Point (NAVICP) Mechanicsburg and NAVICP Philadelphia as part of the provisioning/SSR processes. Navy ERP will process a WS3 transaction response from DLA based on the WS1.
- **b.** <u>Background</u>: When testing started with the Navy ERP, users found that non-standard/legacy transactions (WS1) were sent from the Navy ERP to DLA for processing. The Navy ERP did not have the proper TOC tracking to identify that the WS1 transaction originated from Defense Automatic Addressing System (DAAS) nor did it acknowledge the return (WS3) via DAAS. The TOC used in the WS1 would indicate that it originated from the Navy ERP. The acknowledgement (WS3) via DAAS will be sent back to the Navy ERP.

3. CHANGE IN DETAIL:

a. Technical Details:

- (1) Create a new TOC "Z" to identify transactions originated from the Navy ERP and identify where all transactions returning to Navy ERP would return via DAAS. The new TOC "Z" will be added to the existing list of codes in the DLMS 888W (version 4030) Weapons System Data Change for Qualifier LM Code.
- (2) The Navy ERP will create a WS1 transaction with a TOC of "Z" entered on the WS1 transaction. DAAS will identify the TOC for the point of origination and route the WS1 to DLA EBS for processing. DLA EBS will process the WS1 and return a WS3 via DAAS to the origination point of entry.
 - (3) Update DLMS Implementation Convention (IC) 888W (version 4030) as

shown in Enclosure 1. Replace DLAM 4140.2 Supply Operations Manual with DLAI 4140.38 Weapon System Support Program throughout DLMS IC 888W.

- **b.** Revised Transaction Flow: Recommend a new TOC of "Z" is entered from the Navy ERP tool on all transactions created. The Navy ERP would populate the "Z" in the TOC field on all WS1 transactions with the correct service Routing Identifier Code (RIC) as the RIC-FROM. DAAS would identify the TOC on the transaction to DLA for processing and the return the acknowledgement transaction (WS3) to the correct origination system.
- **4. IMPLEMENTATION TARGET:** Navy ERP and DLA EBS in coordination with DAAS to implement this change upon approval.

5. TECHNICAL IMPACT:

- **a.** Additions or Changes to Data Elements: The TOC of "Z" identifies the Navy ERP as the originating system. This entry identifies the initiation/origination point of the WS1. The following code list will be added to the DLAI 4140.38 Weapon System Support Program (WSSP) Instruction Codes in a future revision:
 - A- Defense Information System Network (DISA)
 - B Base Realignment (BRAC)
 - C Inventory Control Point
 - H DLA Headquarters
 - P Provisioning
 - O Conversion
 - W Web-entered by submitting Service
 - E-FEDMALL
 - Z-Navy ERP

b. Automated Information Systems (AIS):

- (1) DLA Enterprise Business System (EBS)
- (2) Navy ERP must be able to accept or send TOC code "Z" once approved and implemented.
 - (3) Navy Standard Logistic Data Procedures (SLDP)
 - (4) Navy Special System Programs (NSSP)

c. <u>Defense Automatic Addressing System (DAAS)</u>: DAAS will update the current TOC mapping to include TOC "Z" and be able to identify where the transaction originated from as well as send the acknowledged transaction back to the originating system.

6. PUBLICATION/POLICY IMPACT:

- a. Defense Logistics Manual (DLM) 4000.25: Not applicable.
- **b.** Non-DLM 4000.25 Publications: DLAI 4140.38 Weapon System Support Program (WSSP) to be updated with the TOC code list upon approval.

- **9. END-TO-END TESTING REQUIREMENTS:** The Navy ERP application is currently in production. Appropriate testing between Navy ERP, DAAS, and DLA EBS must take place prior to the implementation of this change into a DAAS production environment.


