1. ORIGINATING SERVICE/AGENCY AND POC INFORMATION: Defense Enterprise Data Standards Office (DEDSO), Ben Breen, email: benjamin.breen@dla.mil.

2. REASON FOR CHANGE:

a. Bottom Line Up-Front: This administrative change revises the definition for Supply Discrepancy Reporting (SDR) Discrepancy Code S6-*Shortage due to unit of issue/ unit of pack incompatibility (use only when requisition specified no unit of issue/ unit of pack variance)* to Shortage due to unit of issue/ unit of pack.”

b. Background: DLA requested an update to the definition for SDR Discrepancy Code S6. This request will better align the definition with the actual discrepancies DLA Distribution is currently seeing at time of receipt. The current definition implies the DLA Distribution receiving activities have access to the requisition data of the customer order, which is not the case. Therefore, removing “use only when requisition specified no unit of issue/ unit of pack variance” will align the current SDRs DLA Distribution is creating for shortages for unit of issue. Furthermore, this discrepancy code change was discussed within the SDR Implementation Team meeting held on September 1st 2022, where Components/Services concurred with the proposed definition change.

3. CHANGE IN DETAIL:

a. Technical Details: Revise SDR Discrepancy Code S6 definition as follows: Shortage due to unit of issue/ unit of pack incompatibility. (~~use only when requisition specified no unit of issue/ unit of pack variance~~)

b. Revised Transaction Flow: No impact to SDR process flow.

4. TECHNICAL IMPACT:

a. Additions or Changes to Data Elements: Not applicable.

b. Automated Information Systems (AIS): Component systems will make required updates to change the definition of Discrepancy Code S6. At a minimum the following SDR systems must make updates: WebSDR, Product Deficiency Reporting and Evaluation Program (PDREP), General Service Administration (GSA) Vision, DLA Distribution Standard System (DSS) and Warehouse Management System (WMS), Army Logistics Modernization Program (LMP), Air Force Security Assistance and Cooperation (AFSAC), Air Force Wholesale D035K, Air Force Integrated Logistics System Supply (ILS-S), and DLA Enterprise Business System (EBS).

5. PUBLICATION/POLICY IMPACT:

a. Defense Logistics Manual (DLM) 4000.25: Update Defense Logistics Manual (DLM) 4000.25, Volume 2, Appendix 7.28 Supply Discrepancy Report Relevant Data Elements as shown in above paragraph 3.a.
