Approved Defense Logistics Management Standards Change 1456 Confirmation of Supply Discrepancy Report Cancellations with Reply Code 143

1. ORIGINATING SERVICE/AGENCY AND POC INFORMATION:

- 2. REASON FOR CHANGE: Significant changes after staffing the approved change are in green shade.
- **a.** <u>Bottom Line Up-Front</u>: This change requires action activities to respond with Supply Discrepancy Report (SDR) Reply Code 143 (acknowledgement of cancellation) when a cancellation notice (01) for a Document Type 6 or 7 SDR is received from the submitter.
- **b.** <u>Background</u>: The Air Force Security Assistance Cooperation (AFSAC) team requested that a mandatory Reply Code 143 be required in the SDR process, acknowledging that a record has been cancelled by the submitter. AFSAC uses a SDR system called SDR-A which requires the Reply Code 143 to systematically close the SDR in SDR-A. The lack of Reply Code 143 acknowledgements requires manual intervention and confirmation that the action activity received the SDR cancellation.

3. CHANGE IN DETAIL:

- **a.** <u>Technical Details</u>: When a cancellation notice (01) is submitted for a Document Type 6 or 7 SDR, action activities will respond back with SDR Reply Code 143 (acknowledgement of cancellation) to the submitter.
- **b.** Revised Transaction Flow: Document Type 6 or 7 SDRs cancelled by the submitter will now receive an SDR Reply Code 143 acknowledging the cancellation.
- **4. IMPLEMENTATION TARGET:** DLA has stated that full implementation of this change will occur once Warehouse Management System (WMS) is completely fielded.

5. TECHNICAL IMPACT:

- a. Additions or Changes to Data Elements: None identified.
- **b.** <u>Automated Information Systems (AIS)</u>: At a minimum, the following SDR systems must make updates as outlined in this change: Product Deficiency Reporting and Evaluation Program (PDREP), General Service Administration Vision, DLA Distribution Standard System (DSS), DLA Enterprise Business System (EBS), and DLA Warehouse Management System

(WMS), Army Logistics Modernization Program (LMP), Air Force Security Assistance and Cooperation (SDR-A), Air Force Stock Control System (D035K), and Air Force Integrated Logistics System-Supply (ILSS).

c. Defense Automatic Addressing System (DAAS): None identified.

C17.5.7. Cancellation of an Original Report. When an SDR originator discovers a previously reported SDR is not valid or appropriate for any reason and should be withdrawn, an SDR cancellation must be prepared to cancel the original. The ILCO via the DoD WebSDR will forward to all parties that received the original submission. Cite the original report number and the WebSDR-assigned control number when known. Do not duplicate detail information from the original report except as indicated in the DLMS IC. Provide POC information. A brief narrative description of the reason for cancellation should be included.

C17.5.8. Acknowledgement of the Cancellation of an Original Report. When a cancellation notice (01) is submitted for a Document Type 6 or 7 SDR, action activities will respond back with SDR Reply Code 143 (acknowledgement of cancellation) to the submitter. If the action point does not provide a Reply Code 143 in response to the cancellation after 45 days, the submitter will follow up via email and escalate the issue to Component SDR PRC primary or alternate representative for resolution.
