Approved Defense Logistics Management Standards Change 1462A Expand Usage of Item Unique Identification in the Defense Logistics Management Standards 940R Supporting Defense Logistics Agency Warehouse Management System Functionality (Supply/IUID)

2. REASON FOR CHANGE:

a. Bottom Line Up-Front: Substantive updates made after staffing are identified in green highlighting. This change authorizes the use of the Item Unique Identification (IUID) functionality in the Defense Logistics Management Standards (DLMS) 940R Materiel Release Implementation Convention (IC) as documented in ADC 1073 (reference 12.d.). This change is to enable the fulfilment of materiel release orders (MRO) by serial number (SN) and or Unique Item Identification (UII). If the MRO is denied, DLM 4000.25, Volume 2, Appendix 2.6, Management Codes documented the use of Management Code "T" (Reserved for a denial management code associated with Unique Item Tracking (UIT)) applicable for DIC A6_.

b. **Background**:

- (1) The current business process for DLMS 940R MROs sent from both the Army's Logistics Modernization Program (LMP) and the Marine Corps' Global Combat Support System-Marine Corps (GCSS-MC) to Defense Logistics Agency (DLA) storage activities contain any required exception data in the NTE/0450 segment, to include identification of specific SN requested for release. DLA recently implemented a Warehouse Management System (WMS) which contains expanded warehouse management capabilities that performs automatic picking of materiel based on the requested ownership/purpose data but does not automatically refer to SN information in exception data due to the varied use of the free text field. The current process requires DLA manual intervention to subsequently process a batch substitution and extract the SN and IUID data from the exception data text and manually enter it into the WMS to process the Materiel Release of the requested SN, resulting in additional effort and cost for processing.
- (2) This situation affects Army and Marine Corps materiel releases for specific SNs to include materiel being issued for testing and sampling, Depot Source of Repair, release and shipment of specific items following completion of maintenance or in support of specific contractual specifications, and Foreign Military Sales support. DLA has indicated this workaround is not sustainable and desires Army and USMC MROs for serialized items use a similar process as Air Force items as defined in reference 10.d. It is important to note that this process excludes ammunition and is applicable only for MROs issued from the National Level.

3. CHANGE IN DETAIL:

a. Technical Details:

(1) The Military Services desire the ability to request specific assets from the storage activity by SN. When the SN requested in the 940R MRO is not present at the storage site, the MRO will be denied using the Materiel Release Denial (DLMS 945A with 2/W0611/0200 containing transaction type code NK (MILSTRIP DIC A6_)) response to the requestor referencing the SN requested and use of Management Code T. This is not subject to inventory quantity adjustments at the storage site. The MRO will be processed by UII and/or SN when there is a match with materiel available in storage. Business rules are as follow:

- (2) The MRO will be processed by UII and/or SN when there is a match with materiel available in storage. Business rules are as follow:
- (a) When both the UII and the SN are present and both values match with materiel in storage, the MRO will be fulfilled as requested.
- **(b)** When only the SN is present and there is a match with materiel available in storage, the MRO will be fulfilled as requested.
 - (c) When only the UII is present and not SN, the MRO will be denied.
 - (d) When no serialization data is provided, MRO will be processed as

requested.

(e) When there is no match with the serialization data provided, the MRO

will be denied.

(f) When the SN, national item identification number (NIIN), supply condition code (SCC) do not match, the MRO will be denied.

(3) Ultimately, the materiel owner has the option to request a physical inventory via the DLMS 846P Physical Inventory Request (1/BIA02 code TC Physical Inventory Report (MILSTRIP DIC = DJA)). The storage activity will then count and verify all SNs for the NIIN, SCC, and owner indicated in the request. The storage activity will transmit any inventory adjustments as necessary to correct any discrepancies.

b. Revised Transaction Flow: None

4. IMPLEMENTATION TARGET: DoD Components must evaluate each warehouse management system of record and their corresponding accountable property system of record

(APSR) to determine the level of impact. DoD Components must also plan for implementation as soon as possible but not to exceed 2 fiscal years from approval of this change.

5. TECHNICAL IMPACT:

a. Additions or Changes to Data Elements: See DLMS IC updates in Enclosure 1.

b. Automated Information Systems (AIS):

- (1) DLA WMS: Modify existing logic to read SN/ IUID data in N9/1500 segment from Army LMP and GCSS-MC as is performed for DLMS 940R transactions from the Air Force Retail Supply-Transportation Interface. DLA WMS will also require changes to automatically flag DLMS 940R transactions containing exception data in NTE/0450 segment to be exempt from automatic batch picking until Army and Marine Corps systems implement this change.
- (2) LMP: Modify existing front-end logic and 940R Materiel Release interface to DLA to include SN / IUID data in the N9/1500 segment as opposed to in the NTE/0450 segment.
- (3) GCSS-MC: No changes required. GCSS-MC currently has the capability to include SN/IUID data in the N9/1500 segment.
- **c.** <u>Defense Automatic Addressing System (DAAS)</u>: Coordination to ensure receipt of DLMS 940R Materiel Release both with and without IUID information is properly transmitted to the intended recipient.

 - **c.** GCSS-MC requires no functional changes to allow this change to be implemented.
- **d.** Users of this change have fully implemented the DLMS transaction capability in their business application.
