### Approved Defense Logistics Management Standards Change 1476, Administrative update to transactions 842A/W, 842A/R, and Defense Logistics Manual 4000.25, Volume 2, Chapter 17, Supply Discrepancy Reporting

**1. ORIGINATING SERVICE/AGENCY AND POC INFORMATION:** Defense Enterprise Data Standards Office (DEDSO), Ben Breen, <u>DEDSO.SDR@dla.mil</u>.

#### 2. REASON FOR CHANGE:

- a. **Bottom Line Up-Front**: This change:
- (1) Updates the 842A/W, Standard Supply Discrepancy Report (SDR), Follow-up, Correction, Cancellation, & Reconsideration Request Defense Logistics Management Standards (DLMS) Implementation Convention (IC) notes for the Supply Condition Code (SCC) data element applicable to Document Type Code 5 SDR submissions as shown in Enclosure 1.
- **(2)** Updates the 842A/R, Standard Supply Discrepancy Report (SDR) Reply, DLMS IC notes in the LQ segment position 2/LQ01/4650 to provide clarification to qualifier HD Discrepancy Status or Disposition Code.
- (3) Updates Defense Logistics Manual (DLM) 4000.25, Volume 2, Chapter 17, by moving C17.5.8 which was added by ADC 1456 to new location C17.3.16.1 as shown in Enclosure 2.
- **b.** <u>Background</u>: The DLMS 842A/W DLMS IC currently includes two SCC data elements and clarification between the "FROM" and "TO" is needed for the EDI translation. To further clarify the use of these data elements, the DLMS note for these qualifiers will be updated, see Enclosure 1.
