Rescind Multiple Contracts per DoDAAC Change

3. REFERENCE:

- a.** DoD 4000.25-M, Defense Logistics Management System (DLMS) DLMS Volume 6 (DoD Logistics Systems Interoperability Support Services), Chapter 2 - Department of Defense Activity Address Directory

4. REQUESTED CHANGE:

a. Description of Change: This amends ADC 323 to delete the approved enhancement for adding multiple contracts assigned to a single DoDAAC to the DoDAAD and for modifying the eDAASINQ search capability to query the multiple contract fields. The change from the PDC in the display for DAASINQ and eDAASINQ is highlighted in paragraph 2C.

b. Background:

- (1) DoDAAD Central Service Points (CSPs) are responsible for keeping contract information up-to-date and for deleting DoDAACs with expired contracts.
- (2) ADC 298 implemented mandatory fields for contract information for contractor DoDAACs authorized by DoD 4000.25-1-M, AP2.2, and approved a new search capability in eDAASINQ to assist CSPs in identifying expiring/expired contracts for appropriate action. A requirement limiting one contract per DoDAAC was included in the PDC, but was removed from the ADC because of non-concurrence by some Components. The search capability for a single contract for a DoDAAC has been implemented.
- (3) ADC 323 included approval for adding multiple contracts per DoDAAC into the DLA Transaction Services DoDAAD database to allow CSPs to load all contracts associated with a DoDAAC. It also approved expanding the search capability in eDAASINQ to search for expiring/expired contracts for multiple contracts per DoDAAC. Only Air Force and Navy

reported allowing multiple contracts per DoDAAC. They reported that the longest running contract is entered into the DoDAAD, and that processes are in place external to the DODAAD to track contract expirations. Further, USAF and USN indicated that identifying multiple contracts in the DoDAAD for tracking is not desired. Thus, no requirement for the enhancement currently exists.

- (4) There are adverse impacts to adding multiple contracts per DoDAAC for systems receiving data from DAASC through data replication.
- (5) This topic was discussed at the DODAAD PRC on 18 March 2010 and all participating concurred that ADC 323 should be amended to eliminate the requirement for adding multiple contracts per DoDAAC into the DoDAAD.

c. Procedures:

- (1) Amend ADC 323 to eliminate the requirement to add multiple contract fields per DoDAAC to the DLA Transaction Services DoDAAD database and the requirement to modify the eDAASINQ search application.
- (2) As indicated in ADC 298, DLA Transaction Services add a note to DAASINQ and eDAASINQ indicating ~~“DoDAAC contains one contract, but multiple contracts may be assigned.”~~ **“Note: If multiple contracts are authorized use of this DoDAAC, only the longest running contract is recorded and displayed.”–Staffing Note: See appendix 1 for display of implementation.**

5. REASON FOR CHANGE: No requirement currently exists for adding multiple contracts per DoDAAC to the DODAAD and adding this feature will have a negative impact on systems receiving data from the DoDAAD.

6. ADVANTAGES AND DISADVANTAGES:

- a. Advantages:** Eliminates an approved enhancement for which no requirement exists.
- b. Disadvantages:** None.
