## Approved Addendum 93A to ADC 93 Inclusion of Status Code BP in Cancellation Procedures (Supply/MILSTRIP)

**1. ORIGINATING SERVICE/AGENCY:** DLA Logistics Management Standards Office, 703-767-0676

#### 2. FUNCTIONAL AREA:

**3. REFERENCE:** Approved Defense Logistics Management System (DLMS) Change (ADC) 93, Inclusion of Status Code BP in Materiel Obligation Validation Procedures, March 17, 2003.

### 4. APPROVED CHANGE(S):

- **a.** <u>Brief Overview of Change</u>: This change corrects documented procedures for source of supply processing of single line requisition cancellation requests to check for Status Code BP. This approved change corrects an administrative oversight and allows for staggered implementation if Components do not currently look for Status Code BP on cancellations.
- **b.** <u>Background</u>. Status Code BP was developed for use with extended (or deferred) required delivery date (RDD) procedures (Codes X and S) subsequent to the documentation for Materiel Obligation Validation (MOV) procedures. ADC 93 (see Reference) updated the status codes applicable to MOV to include Status Code BP. Status Code BP applicability to single line cancellation procedures was overlooked at that time. This administrative change is required to correct the oversight and integrate backorders in deferred status during cancellation process. A summary of key codes is provided below.

**MILSTRIP Status Code BP**: Requisition has been deferred per customer instructions. The Estimated Shipping Date is in rp 70-73.

**Extended RDD Code X**: Customer enters number of months in rp 63-64 preceded by an X in rp 62. The use of extended Required Delivery Date Code X does not preclude earlier delivery if materiel is available; however, sources of supply deferring support provide BP status.

**Extended RDD Code S**: Customer enters number of months in rp 63-64 preceded by an S in rp 62. The use of extended RDD Code S indicates the customer's desire that materiel not be released prior to 50 days before expiration of the extended RDD. The source of supply will not ship earlier even if materiel is available.

- c. <u>Revisions to DLM 4000.25 Manuals</u>: Changes to the DLM manuals are identified by *red*, *bold italics* type.
  - (1) DLM 4000.25-1, MILSTRIP Chapter 3
- "C3.28. SOURCE OF SUPPLY PROCESSING OF SINGLE LINE CANCELLATION REQUESTS
- C3.28.1. DICs AC1, AC2, and AC3 cancellation requests (Appendix AP3.7) shall be processed under Subparagraph C3.1.2., including distribution of initial status, as follows:
- C3.28.1.1. First, against backorders in the following order of assigned Status Codes: BB, BC, BD, BP<sup>1</sup>, BZ, and BV."
  - (2) DLM 4000.25, DLMS Manual, Volume 2, Chapter 4
- "C4.7.27. <u>Source of Supply Processing of Single Line-Item Cancellation Requests</u>. Process cancellation requests DLMS 869C, as follows:
- C4.7.27.1. First, against backorders in the following order of assigned Status Codes: BB, BC, BD,  $BP^2$ , BZ, and BV."
  - **d. <u>Proposed Transaction Flows</u>**: No changes to transaction flow are required.
  - e. Alternatives: None identified.
- **5. REASON FOR CHANGE:** This change corrects the administrative oversight to document the use of Status Code BP in regular cancellation request processing by the source of supply.

#### 6. ADVANTAGES AND DISADVANTAGES:

- **a. Advantages:** Corrects documented procedures for requisition cancellations to have source of supply check for Status Code BP.
  - b. Disadvantages: None identified.
- **7. ESTIMATED TIME LINE/IMPLEMENTATION TARGET:** Effective upon approval; authorized for staggered implementation.
