4. APPROVED CHANGE(S): Updates since the staffing of the PDC are highlighted in green.

a. <u>Brief Overview of Change</u>: Correct the DLMS Unit of Material Measure (Unit of Issue/Purchase Unit) Conversion Guide recorded DOD codes for Hundred Pounds (Hundred weight - Short), Hundred Pounds and Minim, and correct the definitions for Thousands of Calories and Hundred Weight – Short (Hundred Weight).

b. Background:

- (1) DLMS Manual, Volume 1, Appendix 4 (Reference 3.a.) specifies DOD data values established in DOD systems must be converted to the corresponding American National Standards Institute Accredited Standards Committee (ANSI ASC) X12 code values for transmission under the DLMS. The Unit of Material Measure (Unit of Issue/Purchase Unit) Conversion Guide is one of three conversion guides used to support DLMS transaction processing. The purpose of the conversion is to allow DOD systems to continue using DOD codes internally, and convert these to X12 codes only during transmission in order to pass translation compliance edits. When DOD codes are identified as missing or new, the equivalent X12 code must be identified and added to the conversion table. The equivalent X12 code may be equal to or similar to the DOD code value.
- (2) The DLA Logistics Management Standards Office recently compared the DOD unit of measure (UoM) codes in the Unit of Material Measure (Unit of Issue/Purchase Unit) Conversion Guide with the DOD Enterprise Standard: Unit of Measure, published by

- ODCMO (Reference 3.b.). That review identified five inconsistencies for UoM used in both communities. Four of the inconsistencies were determined to require a change to the DLMS conversion guide, while the fifth needed to be addressed by ODCMO.
- **c.** <u>Approved Changes in Detail</u>: The DLA Logistics Management Standards Office will update the Unit of Material Measure (Unit of Issue/Purchase Unit) Conversion Guide to correct the DOD code assignments and name descriptions to align with the Reference 3.b. and the FLIS. See Table 1 for a summary of these changes annotated with double strikethroughs for deletions and *red*, *bold italics* for insertions.
- (1) Correct the UoM name description for Hundred Pounds (Hundred Weight Short) to Hundred Weight Short (Hundred Weight). This change aligns it with the equivalent X12 name Hundred Weight Short and the equivalent FLIS DOD name Hundred Weight.
- (2) Correct the DOD UoM code for Hundred Weight Short (Hundred Weight) from HP to HW to properly align with the FLIS DOD code and Reference 3.b.
- (3) Correct the DOD UoM code for Hundred Pounds from HW to HP to properly align with the FLIS DOD code and Reference 3.b.
- (4) Correct the DOD UoM code for Minim from MN to F4 to align with Reference 3.b.
- (5) Correct the UoM name description for Thousands of Calories to Thousands of Dollars to properly align with Reference 3.b.

d. Revisions to DLM 4000.25 Manuals: Update the remarks field in DLM 4000.25 Volume 1, Appendix 4, Paragraph AP4.1, codes *8, **8, and *8* DLMS Unit of Material Measure (Unit of Issue/Purchase Unit) Conversion Guide to reflect its alignment with the DCMO managed DoD enterprise standard for UoM (Reference 3.b) and the Volume 1 rewrite proposed by Reference 3.c. as follows:

REFER TO *OFFICE OF THE DEPUTY CHIEF MANAGEMENT OFFICER*, *DEPARTMENT OF DEFENSE ENTERPRISE STANDARD: UNIT OF MEASURE*, *DATED JANUARY 31*, *2013*, *AND* DEFENSE LOGISTICS MANAGEMENT SYSTEM (DLMS) MANUAL, DLM 4000.25, VOLUME 1 (*C2.5.2.C8.1.5*) AND *VOLUME 2* (*C7.4.1.1.C4.2.2.4*).

- e. Alternatives: None identified.
- **5. REASON FOR CHANGE:** Correct inadvertently swapped HP and HW codes to the proper definition per FLIS, and replace local code MN with X12 code F4 for minim. Correct the inadvertent errors in code descriptions for HW and R5 to align with X12 and Reference 3.b. names.

6. ADVANTAGES AND DISADVANTAGES:

- **a.** <u>Advantages</u>: Aligns the codes with the authoritative FLIS and X12 codes according to the rules to ensure interoperability.
 - **b. Disadvantages:** None.
- 7. ADDITIONAL COMMENTS TO CONSIDER: While this ADC addresses corrections to the DLMS conversion guide, ODCMO was informed of the need to reflect the DOD UoM code for mile as MI in the Department of Defense Enterprise Standard: Unit of Measure. Per Reference 3.d., ODCMO made this change and indicated the change will be reflected in the Business Enterprise Architecture Version 11.0 to be released February 2014.
- **8. ESTIMATED TIME LINE/IMPLEMENTATION TARGET:** Joint implementation date of September 30, 2013.

9. IMPACT:

- a. New DLMS Data Elements: None.
- **b.** <u>Changes to DLMS Data Elements</u>: The Unit of Material Measure (Unit of Issue/Purchase Unit) Conversion Guide must be updated to the DOD codes and definitions as shown in Table 1, as well as alignment with the DCMO Conversion Guide as shown in paragraph 4.d.

c. Automated Information Systems (AIS):

(1) Component applications will need to implement the conversion guide to the corrected DOD codes and definitions for transaction exchange.

- (2) Wide Area Workflow (WAWF) Program Manager must review for consistency with implemented UoM values and provide transition guidance if required.
- **d. <u>DLA Transaction Services</u>**: Implement the conversion guide to the corrected DOD codes.
- e. <u>Non-DLA Logistics Management Standards Publications</u>: ODCMO updated reference 3.b. to reflect the correct DOD code for mile as MI vice DH. This change will be published to the BEA in February 2014.
