4. APPROVED CHANGE(S):

a. <u>Brief Overview of Change</u>: This administrative change documents the removal of all Standard Exchange Format (SEF) files and DLMS Enhancement files from the DLMS Implementation Convention (IC) web page (Reference 3.a.). This change does not affect any procedures.

b. **Background**:

(1) Standard Exchange Format (SEF) Files:

- (a) Historically, the Enterprise Business Standards Office (EBSO) was required to submit SEF files to the Electronic Data Interchange Standards Management Committee (EDISMC) and the Federal EDI Standards Management Coordinating Committee (FESMCC) repository in support of the Logistics Functional Working Group (LFWG). Throughout the 1990s and into the 2000s, EBSO developed DOD ICs as supplements to overarching Federal ICs and contributed to developing the Federal ICs. In the 2000s, the EDISMC coordination effort moved under the Business Transformation Agency (BTA). Funding for the various standards management committees stopped and at some point in the early to mid-2000s, the Federal coordination effort of the FESMCC, DOD EDISMC, and LFWG ceased to operate.
- **(b)** Approved DLMS Change (ADC) 1344 (Reference 3.b.) removed numerous outdated and unused Federal ICs from the EBSO website. ADC 1345 (Reference 3.c.) completed the removal process by converting the remaining four Federal ICs to DLMS ICs.
- (c) The Military Surface Deployment and Distribution Command (SDDC) was the only known user of the SEF files in support of its previous electronic data interchange (EDI) and data translation solution. The SDDC's current translation capability no longer requires SEF files.
- (d) Based on the above, EBSO determined that the SEF files no longer serve any purpose and will therefore remove the files from the its website.

(2) DLMS Enhancement Files:

- (a) The original intent of DLMS enhancement files was to capture enhanced capabilities within each DLMS IC and to document the specific ADCs that added or updated DLMS enhancements within an IC. DLMS enhancements are capabilities (such as the exchange of item unique identification (IUID) data) that are available in the variable length DLMS transactions (DLMS EDI or DLMS XML) but cannot be implemented or exchanged in non-DLMS format (80 record position legacy DLSS/MILS) transactions.
- **(b)** Over time, EBSO added all changes affecting a specific DLMS IC to the respective DLMS enhancement file, which turned the enhancement files into nothing more

than a change history for DLMS ICs and thereby usurping the original purpose. Each DLMS IC contains a list of all ADCs that affected the implementation convention. The ADCs themselves provide the background and details for each change.

(c) Due to the redundant nature of information contained in the DLMS enhancement files, EBSO determined that files no longer serve a purpose and will therefore remove the files from the its website.

c. Approved Change in Detail:

- (1) Stop updating and publishing the SEF files and the DLMS enhancement files.
- (2) Remove all SEF files from the DLMS IC column on the DLMS IC web page.
- (3) Remove the DLMS enhancements column and DLMS enhancement files from the DLMS IC web page.
 - (4) On the DLMS IC web page change:
- (a) FROM: "This page contains several formats of the Implementation Conventions: ANSI ASC X12: .pdf *and .sef*; XML Schema .xsd."
- **(b)** TO: "This page contains several formats of the Implementation Conventions: ANSI ASC X12: .pdf; XML Schema .xsd."
- (c) Change the column name "DLMS IC*" to "DLMS IC & XML Schema"
- (5) Remove the paragraph about SEF formatted files from the Transaction Formats web page (Reference 3.d.).
- **d.** Revisions to DLM 4000.25 Manuals: Revise the following paragraph in DLM 4000.25 Volume 1, Chapter 3, Change Management:
 - "C3.4.4.9. Step 9. The DLMS PRC Chair will prepare the ADC by updating the PDC content based on adjudication of Component responses to the PDC. This includes the following:
 - Formalize changes to DLM 4000.25 series of manuals.
 - Formalize changes to DLMS ICs.
 - Create SEF and XSD files in support of DLMS IC changes."
 - e. Proposed Transaction Flow: None
- **f.** <u>Alternatives</u>: Continued updating and publishing of the SEF and DLMS enhancement files can be confusing to users and serves no practical use.
- **5. REASON FOR CHANGE:** The SEF files are no longer required and DLMS enhancement files consist of redundant information.
