# 3 REQUESTED CHANGE

---

## 3.1 BRIEF OVERVIEW OF CHANGE

This Approved Cataloging Data Change (ACDC) documents the addition of two new Major Organizational Entity (MOE) Rules A754 and A755 as requested by the US Army, in which US Army AMCOM Aviation acts as the Secondary Inventory Control Activity (SICA) and the Federal Aviation Administration (FAA) as the Primary Inventory Control Activity (PICA).

## 3.2 REQUESTED CHANGE IN DETAIL

### 3.2.1 Background

Per Cataloging Data and Transaction Standards, Volume 13, Chapter 6, "The MOE Rule Table, Appendix 13-6-B, reflects management responsibilities within participating Military Services, Civil Agencies, and NATO and other foreign countries. The information included in the MOE Rules is a combination of Department of Defense (DoD) and Service/Agency cataloging/supply management assignments which are made on the basis of organizational responsibilities."

### 3.2.2 Creation of New MOE Rules, A754 and A755

Fixed Base Air Traffic Control products are currently sustained by CECOM, but sustainment responsibilities are transitioning to AMCOM (see attached LOI signed by ALC and CECOM LSC Directors).

As a result, AMCOM Aviation requires creation of two new MOE Rules for AMCOM Aviation (Activity Code "CT") to be the SICA, with FAA acting as the PICA (Activity Code "48"): A754 and A755.

The PICA and SICA MOE Rules drive business rules for what a user can and cannot do on a National Stock Number (NSN). With this addition, FAA can support the AMCOM Aviation as a user on NSNs where the AMCOM Aviation SICA MOE Rule is present. Without these MOE Rules, AMCOM Aviation cannot be added as a SICA of FAA NSNs and the FAA cannot provide support for these items.

### **3.3 REASON FOR CHANGE**

Product Managed Assured Airspace Access (A3S) has nine programs transitioning from CECOM to AMCOM on 1 October 2020. In accordance with FLIS Technical Procedure, Volume 6, Section 6.3.11, AMCOM Aviation must be recorded as a SICA user in order to be supported by FAA. If the rules are not established, the system will reject any attempt to add AMCOM Aviation as SICA. Subsequently, AMCOM would not be able to order, repair, or turn-in stock from/to FAA without being recognized as an authorized SICA user.
