This change impacts the Federal Logistics Information System (FLIS).

3 REQUESTED CHANGE

3.1 BRIEF OVERVIEW OF CHANGE

This change removes Major Organizational Entity (MOE) Code WN from Cataloging Data and Transaction Standards 10 and 13, as agreed upon during the 135th AC/135 Panel A Meeting.

3.2 REASON FOR CHANGE

3.2.1 Background

The NATO Support and Procurement Agency (NSPA) informed AC/135 that Major Organizational Entity (MOE) Code WN, the Activity Code WN, and MOE Rule WN01, all previously utilized in the NSPA electronic Ammunition Database (NSPA eNADB) are no longer required for use.

NSPA proposed deletion of the MOE Code "WN" from ACodP-1 Table 18 and CodSP-3, and received approval during the 135th Panel A Meeting. As a result, the NSPA de-registered the aforementioned codes from all NSNs within internal codification as well as within the NATO Master Catalogue of Reference for Logistics (NMCRL). The Panel asks that the U.S. also delete MOE Code WN from Cataloging Data and Transaction Standards Volume 10 and 13.

3.2.2 Major Organizational Entity (MOE) Code

CDTS, Volume 10, Table 51 contains Major Organizational Entity (MOE) Codes. The MOE Code is a two character code representing a subdivision of the North Atlantic Treaty Organization (NATO), other allied governments and international organizations participating in the Federal Catalog Program. This change removes MOE Code WN, NATO NADB, from CDTS, Volume 10, Table 51.

3.2.3 Activity Codes and Addresses for Authorized Originators, Submitters, MOE Codes, and RNAACs
CDTS, Volume 10, Table 104 contains Activity Codes and Major Organizational Entity (MOE) Codes for authorized originators and submitters. These codes identify activities authorized to submit and receive Cataloging Transactions. This change documents the removal of Activity Code WN, NATO NADB, from CDTS, Volume 10, Table 104.

3.2.4 Removal of MOE Rule WN01

The MOE Rule drives business rules for what a user can and cannot do on a National Stock Number (NSN). With this removal, NSPA will no longer be a user on NSNs.
