3 REQUESTED CHANGE

3.1 BRIEF OVERVIEW OF CHANGE

This approved addendum to Administrative Approved Cataloging Data Change (ACDC) 0001 documents the correction of the submitter information for 20 Major Organizational Entity (MOE) Rules previously requested by the USMC. The 20 updated MOE Rules have a new effective date of 2018352 or December 18th, 2018. The updated information is already implemented in FLIS.

3.2 REQUESTED CHANGE IN DETAIL

Per Cataloging Data and Transaction Standards, Volume 13, Chapter 6, "The MOE Rule Table, Appendix 13-6-B, reflects management responsibilities within participating Military Services, Civil Agencies, and NATO and other foreign countries. The information included in the MOE Rules is a combination of Department of Defense (DoD) and Service/Agency cataloging/supply management assignments which are made on the basis of organizational responsibilities." Appendix 13-6-C conveys the same information, but lists the MOE Rules sequentially by Activity Code versus MOE Rule.

This addendum documents a correction of the submitter information to the 20 new MOE Rules, which USMC requested to be added in ACDC 0001.

In order to correct the submitter information in FLIS, the affected MOE Rules had to be first deleted and then re-created with the correct submitter edit. This resulted in a new effective date of 2018352, or December 18th, 2018.

3.3 REASON FOR CHANGE

Correction of erroneous submitter information, resulting in new effective date.
