3 REQUESTED CHANGE

3.1 BRIEF OVERVIEW OF CHANGE

This administrative change documents updates and additions to Cataloging Data and Transaction Standards (CDTS), Volume 10, Table 117, Depot Source of Repair (DSOR) Code to Maintenance Activity Cross Reference, and associated FLIS DB2 Tables, resulting from annual Service updates. The US Navy, US Air Force, and US Army Services Maintenance Interservice Support Management Offices (MISMOs) coordinated and approved the documented changes in accordance with DSOR processes outlined in Service-level policies and procedures.

This administrative change also approves a correction of DSOR Code AU in Volume 10, Table 117 to harmonize the entry with the corresponding FLIS DB2 table, as well as an update to language in Table 117, Part 1 to update referenced policy.

3.2 REQUESTED CHANGE IN DETAIL

3.2.1 Background

CDTS, Volume 10, Table 117 encompasses two parts relating to Depot Source of Repair (DSOR) Codes. Part 1 identifies the activities with approval to perform depot level maintenance for the Services. The Services' Maintenance Interservice Support Management Offices (MISMOs) develop and manage DSOR codes and their use.

Part 2 identifies the service MISMOs. Any recommended additions, changes (including organizational name) or deletions to the DSOR codes must be submitted to the affected Service MISMOs for approval.

3.2.2 US Navy Updates

The US Navy MISMO approves the addition of **DSOR Code SO** for **Fleet Readiness Center, Aviation Support Equipment (FRC ASE), Solomons, MD** to CDTS, Volume 10, Table 117, Part 1.

FRC ASE is recognized across Naval Air Systems Command (NAVAIR) as a leader in depot level repair of avionics support equipment (SE), and SE components, including Fleet ground support equipment (GSE), test and repair machinery, fixtures, and tooling. FRC ASE works closely with organizational level squadrons, support equipment controlling authorities, and Fleet Readiness Centers worldwide. Additionally, FRC ASE provides readiness to the Fleet by supporting all platforms, aviation type/model/series aircraft, engines, and components across all of the Navy Program Offices. The organization provides direct support to Naval Aviation Programs through its Aviation Support Equipment depot level workload.

The RQ-21 Blackjack Program, also known as PMA-263 RQ-21A Unmanned Aviation Systems, requires immediate support at FRC ASE. Due to support performance issues, the Program must transition from Original Equipment Manufacturer (OEM) commercial support to organic support. As a result, this change requires expeditious handling and implementation.

3.2.3 US Air Force Updates

The US Air Force MISMO approves the <u>addition</u> of **DSOR Code FG** for **Air Force Gunsmith Shop (GSS)**, **Joint Base San Antonio (JBSA)**, **Medina Annex**, **TX (AFGSS-JBSA)** to CDTS, Volume 10, Table 117, Part 1.

This change adds Air Force GSS to Table 117, enabling its operation as a non-standard depot/overhaul/repair/modification facility specializing in the overhaul and repair of Small Arms (.50 caliber and below) and Light Weapons (SA/LW). The GSS provides weapons sustainment and technical solutions for ground fired small arms and supports the US Air Force through rapid response. Expedited handling of this change is required.

The US Air Force MISMO further approves <u>updates</u> to four existing entries. The previous annual update to Table 117 did not include the mission activities' names in their entirety.

The following shows the full names as they will appear in Table 117:

- FI 520th Software Maintenance Group (SMXG), Patrick AFB, FL
- FP 526th Equipment Maintenance Group (EMXG), Support Center Pacific (SCP), Kadena AB, Japan
- FV 583rd Missile Maintenance Group (MMXG), Vandenberg AFB, CA

3.2.4 US Army Updates

The US Army MISMO approves the <u>deletion</u> of **DSOR Code FV** for **Fort Lee**, (**CECOM, SEC**), Virginia, VA from CDTS, Volume 10, Table 117, Part 1, and approves the <u>addition</u> of **DSOR Code VA** for **Fort Lee**, (**CECOM, SEC**), Virginia, VA.

Changing the DSOR code for maintenance activity Fort Lee, (CECOM, SEC), Virginia, VA from FV to VA is necessary due to a duplication of DSOR Code FV in Table 117. The second DSOR Code FV, is already assigned to US Air Force Maintenance Activity Vandenberg AFB, California, CA.

The US Army MISMO further approves an <u>update</u> to the maintenance activity name for **DSOR Code RT** to read **US Army Combat Capabilities Development Command (CCDC) Armaments Center, Redstone Arsenal, AL Sierra**. The update comes as a result of a US Army reorganization effort.

3.2.5 FLIS DB2 Table Harmonization

A comparison between Volume 10, Table 117 and the corresponding FLIS DB2 Table 833 showed a discrepancy in the entries of both tables for DSOR Code AU. This change approves <u>updating</u> the Service category for **DSOR Code AU** to **Other**.

3.2.6 Update Referenced Policy and Procedures

The information for Table 117, Part 1 references Joint Service Regulation, AMC-R 750-10, OPNAVINST 4790.14B, MCO P4790.10B, DLAD 4151.16 for DSOR assignment procedures. This Joint Publication is cancelled and requires updating the reference in Table 117, Part 1. Since the cancellation, the DSOR process is implemented in accordance with Service-level policies and procedures. Applicable Service regulations/instructions include:

3.3 REASON FOR CHANGE

3.3.1 US Navy

This change adds DSOR Code SO for Fleet Readiness Center, Aviation Support Equipment (FRC ASE) to Table 117 in anticipation of future depot level repair requirements and workload generated by PMA-263 RQ-21A Unmanned Aviation Systems.

3.3.2 US Air Force

This change adds DSOR Code FG for Air Force Gunsmith Shop (GSS), Joint Base San Antonio (JBSA), Medina Annex, TX (AFGSS-JBSA) to Table 117 in anticipation of future depot level repair requirements and workload generated by the US Air Force. The workload requires repair at an organic activity for rapid response.

The updates to the four existing entries to show the full names of the respective maintenance activities were not added during the previous annual Service update.

3.3.3 US Army

Changing DSCOR Code FV for Fort Lee, (CECOM, SEC), Virginia, VA to VA is necessary to eliminate the duplication of code FV in Table 117.

The update of the maintenance activity name for DSOR Code RT is required due to a US Army reorganization effort which resulted in organization name changes.

3.3.4 FLIS DB2 Table Harmonization

Changing the Service category for DSOR Code AU to 'Other' is necessary to correctly reflect the appropriate Service category in Volume 10, Table 117.

3.3.5 Update Referenced Policy and Procedures

This change updates language in Table 117, Part 1 due to the cancellation of Joint Service Regulation, AMC-R 750-10, OPNAVINST 4790.14B, MCO P4790.10B, DLAD 4151.16.

Recommended additions, changes (including organizational name) or deletions to the DSOR codes identified shall be submitted to the affected Service MISMOs as listed in Part 2 of this table. All changes to Table 117 must be approved by the Service MISMOs.
