# 3 REQUESTED CHANGE

---

## 3.1 BRIEF OVERVIEW OF CHANGE

This change documents a correction to Cataloging Data and Transaction Standards (CDTS), Volume 13, Chapter 6, Appendix 13-6-A, Wholesale-Retail Grid, for Secondary Inventory Control Activity (SICA) Level Of Authority (LOA) 8D.

## 3.2 REQUESTED CHANGE IN DETAIL

CDTS, Volume 13, Appendix 13-6-A, Wholesale-Retail Grid “lists the various levels of Service/Agency supply management responsibility. Information is provided for the Primary Inventory Control Activity (PICA) and Secondary Inventory Control Activity (SICA), Integrated and Non-Integrated Material Managers and for all the related levels of authority specific to each.”

Under the Non-Integrated Management portion of the table, a typographical error cites SICA LOA 8D to correspond with PICA LOA 06. However, per Volume 13 as well as other citations on the wholesale-retail grid, the PICA LOA should instead be 22, as this is for nonconsumable items. See enclosure for the correction.

FLIS DB2 Tables 093-MOE\_RULE\_TBL, and 152-MOE\_RULE\_PS\_EDITS contain the correct business rules, requiring only updates to CDTS Volume 13, Appendix 13-6-A.

## 3.3 REASON FOR CHANGE

This change ensures correct documentation of LOAs and subsequent business rules for both PICA and SICA Major Organizational Entity (MOE) Rules, as well as proper management of nonconsumable items.
