3 REQUESTED CHANGE

3.1 BRIEF OVERVIEW OF CHANGE

This Cataloging Data Change documents the addition of Army Materiel Category Code U4 and L0 to Cataloging Data and Transaction Standards, Volume 10, Table 65, Army Materiel Category Codes, Position 4 and 5, as requested by US Army.

3.2 REQUESTED CHANGE IN DETAIL

3.2.1 Background

Found within Cataloging Data and Transaction Standards, Volume 10, Table 65, the Army Materiel Category Code is a five-position alphanumeric code that indicates the financial category of an item for Army accountability. Position 4 of the Army Materiel Category Code signifies special or specific groups of items on a generic basis. In conjunction with Position 4, Position 5 identifies a specific weapon system/end item or homogenous group of items.

3.2.2 Army Materiel Category Code Codes U4 and L0

Already present within both the Federal Logistics Information System (FLIS) and US Army Systems, US Army requests the addition of Position 4 and 5 combinations U4 and L0 with corresponding weapon system descriptions to Cataloging Data and Transaction Standards, Volume 10, Table 65. 3.3 REASON FOR CHANGE

The Army requires two new codes for the Next Generation Automatic Test System (NGATS), which is an off platform test station with the ability to test a wide array of weapon systems by using additional test hardware packages. The new codes will support the test station itself as well as the Abrams/Bradley test hardware package.
