3 REQUESTED CHANGE

3.1 BRIEF OVERVIEW OF CHANGE

This change documents the addition of Army Materiel Category (MATCAT) Code 60, Squad Designated Sniper Rifle, to Cataloging Data and Transaction Standards (CDTS), Volume 10, Table 65, Army Materiel Category Codes, Position 4 and 5 as requested by US Army.

3.2 REQUESTED CHANGE IN DETAIL

The Army Materiel Category Code is a five-position alphanumeric code that indicates the financial category of an item for US Army accountability. Position 4 of the Army Materiel Category Code signifies special or specific groups of items on a generic basis. In conjunction with Position 4, Position 5 identifies a specific weapon system/end item or homogenous group of items.

Establishing new codes enables the US Army to clearly distinguish between weapon systems.

The US Army requests the addition of Materiel Category Code 60 to appropriately identify and support items associated with the Squad Designated Sniper Rifle weapon system in both FLIS and US Army Legacy Systems.

3.3 REASON FOR CHANGE

In addition to the aforementioned requirements to uniquely identify items associated with particular systems, FLIS will reject Cataloging transactions from US Army if an Army Materiel Category Code, in this case 60, is not presently in the DB2 Table. As a result, this code must be added to prevent rejections.
