# 3 REQUESTED CHANGE

## 3.1 BRIEF OVERVIEW OF CHANGE

This Administrative Approved Cataloging Data Change (ACDC) documents the addition of the new Navy Special Materiel Identification Code EL, (E-2C/E-2D Common Aircraft), as requested by USN.

## 3.2 REQUESTED CHANGE IN DETAIL

### 3.2.1 Background

Per Cataloging Data and Transactions Standards, Volume 10, Table 60, the Navy Special Materiel Identification Code (SMIC) is a “two-position alphanumeric code used by the Navy to categorize materiel on the basis of requirements for source or quality control; technical design or configuration control; procurement, stocking and issue control; special receipt, inspection, testing, storage, or handling.”

### 3.2.2 US Navy Special Materiel Identification Code (SMIC) EL

This change impacts DB2 Table 254, NVY\_SPEC\_MTL\_ID\_CD. See Enclosure 2 for details.

## 3.3 REASON FOR CHANGE

This change documents the US Naval aviation requirement for SMIC identifier “E-2C/E-2D COMMON AIRCRAFT” within Navy ERP. USN requires this new code to more closely monitor and control special stock related to the E-2C/E-2D missions.
