### 3.1 BRIEF OVERVIEW OF CHANGE

Update Cataloging Data and Transaction Standards (CDTS), Volume 10, Table 9, to include the country Jordan.

### 3.2 REQUESTED CHANGE IN DETAIL

Update CDTS, Volume 10, Table 9, by adding a record of National Codification Bureau (NCB) code 78 for the country Jordan to align with the associated FLIS DB2 Table 251.

### 3.3 REASON FOR CHANGE

A recent review of CDTS, Volume 10, Table 9, National Codification Bureau Codes, and the associated FLIS DB2 Table 251 (NATL\_CDFN\_BUREU\_CD), identified a missing record for the country Jordan in Volume 10, Table 9. This update will harmonize Volume 10 and FLIS DB2 tables to reflect accurate NCB code data.
