I. PURPOSE

The Defense Enterprise Data Standards Office (DEDSO) received formal concurrence from the Deputy Assistant Secretary of Defense for Logistics ODASD(Log) on Approved Defense Logistics Management Standards (DLMS) Change (ADC) 1443 Product Quality Deficiency Report (PQDR) Policy Migration. ADC 1443 was signed on 27 January 2023. This ADC serves to inform the Department of Defense (DoD) Components that the Defense Logistics Manual (DLM) 4000.25, Volume 2, Chapter 24, is replacing Joint Service Regulation Defense Logistics Agency Regulation 4155.24/AR 702-7/SECNAVINST 4855.21/AFI 21-115/DCMA INST 1102 as the DoD authoritative source for PQDR-related guidance.

IV. AGENDA ITEMS

a. **Proposed DLMS Change (PDC) 1443C PQDR Policy Migration:**

Ben Breen, PQDR Administrator, announced that the PQDR Technical/Policy working group meeting schedule for 24-27 June will be conducted virtually due to unapproved travel requests. DEDSO stressed that this will be a decision-making meeting and dedicated participation of the primary/alternate committee members is required.

Ben discussed the continuation period for the PDC 1443C draft version of Chapter 24 rewrite, and requesting final responses be submitted for discussion before the meeting on June 11, 2025. Ben's expectations are that this extended pre-coordination upfront would expedite the formal response period by addressing questions prior to routing for formal signature approval.

b. **Proposed PQDR 1007F Status Update:**

Ben informed the committee that his intent is to finalize the proposed additions to the draft PDC 1007F that documented the data element changes and other codes in support of 842P implementation as soon as possible to support testing. As an action, he requested that the components comment whether they concur or non-concur with the addition of the JDRS cancelation codes before the 11 June meeting. Additional clarification and amplifying information to assist in decision making for the proposed JDRS cancelation codes was presented during the meeting, as listed in the original agenda posted on May 23, 2025, to the PQDR Teams channel.

It was noted that most of the cancelation codes previously in DLMS Volume 2 Supply Standards and Procedures Appendix 7.27 were related to Exhibits, so these JDRS additions were making the list more inclusive. Ben requested that the committee review the different system implications for any approved cancelation codes that they still may want to suppress for some reason.

Ben also remarked on the need for the review and potential removal of the SPS code, if determined by the committee that it is a duplication of POL or FDD information.

Further committee discussions centered on the potential to reduce redundancies, as certain transaction codes inherently eliminate the need for a general correspondence code to express the same action. In addition, the committee determined a need for closing codes versus cancelation codes to be clearly defined to reduce redundancy.

Ben briefed that DEDSO is currently developing 842P future state process flow charts to help provide visual guidance and clarity on transactions to account for different scenarios.

c. **DLMS Summit:**

The virtual DLMS Summit date is still to be determined.

DEDSO will be posting agenda and new dates on our website, through our newsletter, and via the PRCs and working groups.
