1. GFP PDCs

- a. Internal Meeting to be scheduled between DLA and DEDSO to touch base on any feedback or comments as the date was extended until June 11th. Looking to schedule that somewhere between Thursday (6/11/26) and Monday (6/15/26) of next week.
 - i. **1517**
 1. Identify the GFP fields and assist in tracking the property systems Product IDs added for a single capability being added to the 9471, 527R, 856S also adding UII information.
 2. Support new data elements to convey UII:
 - a. 9471
 - i. Unit Acquisition Cost

- ii. Category Code (Equipment or Material)
 - iii. Not Special Tooling or Test Equipment Status (NS), Special Test Equipment (STE), or Special Tooling (ST)
 - b. 527R & 856S
 - i. Modified to include Product / Service ID
 - ii. **1515**
 - 1. Convey multiple Government Furnished Property (GFP) Product/Service Identification (ID) changes to an APSR in one transaction.
 - 2. Changing four metadata attributes for one product
 - iii. **1520**
 - 1. This change will primarily affect JSF transactions related to Enterprise Logistics Management System (ELMS) and the Procurement Integrated Enterprise Environment (PIEE) GFP Module.
 - 2. All other systems using the DLMS 945A for GFP shipments should review for use.
- 2. 846R – Updates**
 - i. Adding a new qualifier for storage bin location in the transaction to give a more granular picture of where the materiel is at for NWRM and F35. Two systems:
 - 1. PIC Fusion
 - a. NWRM Tracking & Reporting
 - 2. PDC 1532 – F35 | ALIS | ELMS – ADC by July 1st, 2026
 - a. 846R
 - b. 527R
 - c. 867I
 - d. 947I
- 3. 940R 4050 Version**
 - a. AF is currently the only component which will be sending these three additional costs on the 940R – current delays at customs
 - i. Are there other services that are also getting complaints or delays?
 - b. DEDSO to only maintain one version on their site.
