V. Agenda Items

1. PDC 1533 - Restitution Tracking for Product Quality Deficiencies, PQDR – Joint PDC

- a. Requirements in this change directly support resolving department-wide issues with effectively documenting evidence of contractor restitution obtained when the contractor is found liable for supplying defective parts.
- b. OIG Signed Policy by 10/31/2026

2. Transaction Tracing ST02 Segment (Paper Submission)

- a. We are seeking Component input on standardizing the use of the EDI ST (Transaction Set Header) segment to establish a single, unique identifier for end-to-end transaction tracing, ensuring full audit completeness and accuracy. The ST02 is a 4-to-9 character alphanumeric control number assigned by the originator.
 - i. Are Components currently utilizing the ST segment in all transactions as a unique identifier for tracking?
 - ii. Can your legacy and modern systems successfully send and receive both the ST01 and ST02 elements?
- b. DAAS currently removes the ST segment during validation. DAAS is actively working to restore/retain this value for DLA-to-DLA transactions (specifically supporting WMS and EBS). During recent leadership discussions, the OSW emphasized the critical need for standardization. Implementing the ST segment across the board will aid in Audit Completeness and Accuracy standards.
 - i. **Received information from Army**
 - 1. LMP populates this with a combination of the GS control number and a part of the outbound IDoc number
 - 2. LMP sends the ST01 and ST02 outbound, and while we do not process the inbound ST01 and ST02 segments we do use them to identify rejected inbound DLMS transactions to DAAS
 - 3. INBOUND transactions to Army LMP the ST segment is dropped but DAAS does in fact send ST segment
