SUBJECT: Proposed MILSTRIP Change Letter (PMCL) 14, Unit Price on DI AS3 for Shipments to DRMOs

1. References:

- a. DoD 4000.25-1-M, MILSTRIP, 1 May 1987.
- b. DoD Directive 4000.25, 18 November 1983, subject: Administration of Defense Logistics Standard System.
- c. DLSSO-BM letter, 15 January 1988, subject: Approved MILSTRIP Change Letter (AMCL) 158A, Intransit Control of Shipments to Defense Reutilization and Marketing Offices (Staffed by PMCL 469).
- d. DLA-OSC letter, 11 April 1988, subject: Proposed Change to MILSTRIP, DoD 4000.25-1-M.

2. Proposed Change Concept/Rationale:

- a. Concept: This proposed change refines MILSTRIP on the use of DI Code AS3 shipment status documents to include the unit price for shipments to disposal.
- b. Rationale: When DoD activities begin submitting the AS3 to DRMS for all shipments to DRMOs, DRMS will pass through to the intransit control system only those items that qualify. In order for DRMS to make this decision, the unit price is necessary, particularly on non-NSN shipments, since the price data would not be available in the DIDS TIR.

3. Interface/Impact Requirements:

- a. Interface: Requires an interface between MILSTRIP, Service/Agency (S/A) activities, and DRMS.
- b. Impact: Narrative changes will be required on all interfacing systems and to MILSTRIP, reference 1.a. A change to S/A systems will be required to include the unit price on the DI Code AS3 for shipments to DRMOs.

4. Advantages/Disadvantages:

- a. Advantages: Will allow DRMS to set up the due-in file for the DRMOs, while setting up the intransit control system suspense file with only those AS3 shipment records that qualify for intransit control, thereby precluding unnecessary followups.
- b. Disadvantages: See the impact statement in paragraph 3.b above.

5. Procedures: See attachment 1.

Proposed MILSTRIP Change Letter (PMCL) 14,
Unit Price on DI AS3 for Shipments to DRMOs

1. Revise current MILSTRIP, chapter 3, paragraph LL.1.c. as follows:

c. Materiel will be directed/processed to disposal under the procedures outlined in paragraphs MM. and NN., utilizing the DTID (using DD Forms 1348-1 or 1348-1A). At the time materiel is physically shipped/transferred to the DRMO, a shipment status transaction (DI AS3), with Distribution Code 9 in rp 54, reflecting actual quantities shipped, the date shipped, and the unit price of the materiel shipped in rp 62-68 will be furnished to the DRMS per chapter 4, paragraph H. See appendix C17 for format and required entries on shipment status transactions furnished to DRMS. Activities will furnish DI AS3 to DRMS for all shipments of usable property to DRMOs without regard to dollar value. DRMS will process DI AS3 to the intransit control system when the dollar value is \$800 or more and for all sensitive/pilferable items regardless of dollar value. The shipment status transaction (DI AS3), meeting the intransit control criteria, will initiate the suspense file at DRMS which will, as a minimum, contain the following data: *

2. Chapter 4, revise paragraph H.2.b. as follows:

b. For each shipment on a DTID, shipping activities will furnish shipment status (DI AS3 with Distribution Code 9 in rp 54 and the unit price of the materiel shipped in rp 62-68) to the DAAS for transmission to DRMS. *

3. Appendix A15, delete the second and third sentences of paragraph b. that read:

"This method of transmission is limited to 66 characters of data per line (i.e., rp 1-66), unless the teletype terminal has been modified to accommodate up to 80 characters per line. If such modification has taken place, 80 characters per line is acceptable since DAAS can process the 80 characters per line."

4. Appendix A15, revise the fourth sentence of paragraph b. to read:

"Submit data required by the MILSTRIP transaction formats shown under appendix C." *

5. Appendix C17, delete the entry and instructions paragraph h. under the field legend for TCN, GBL, or other shipment unit number and add the following:

"Entries Required for Shipments to Disposal."
