**9. DESCRIPTION OF AMENDMENT/MODIFICATION (Except as provided below all terms and conditions of the document referenced in Item 5 remain in full force and effect)**

A twelve (12) month option period is being exercised in accordance with pages 8, 11 & 12 in the general statement of the contract, and Article Five, Section One of the contract: The minimum requirement for the option period is an additional 80,000 DTID's or property having an original acquisition value (OAV) of \$100 million, whichever is the lesser amount. The maximum requirement for the option period is an additional 150,000 DTID's or property having an OAV of \$550 million, whichever is the greater amount to stay within the limits of the contract. The base period is effectively being reduced from 24 months to 21 months. The overall permitted length of the contract will be reduced from 60 months to 57 months, assuming all other options are exercised. The period of performance (PoP) for the 1st option period will take effective immediately upon the base period hitting the maximum DTID's or OAV allowed (whichever is greater) as described above. The date on which the base period maximum is hit will be the first day in the PoP of the 1st option period and will operate for 12 months from that date. The Sales Contracting Officer will issue a unilateral contract modification specifying the exact dates of the 1st option period of performance upon it commencing.

**CLAIMS:** I hereby understand that by bilaterally signing this contract modifications that I release the US Government, its officer, agents, and employees of and from all liabilities, obligations, claims, appeals and demand which it now has, whether administrative or judicial, legal or equitable arising under or in any way related to the base period of performance in IFB 21-069-001.
